SUBJECT: 4th Street and P Street Traffic Signals (CC:9728) -
Appropriation of Funds

SUMMARY

Plans and specifications for this project have been prepared.
Appropriation of funds to cover the cost of construction is recommended.

BACKGROUND

This project will install traffic signals at 4th and P Streets to control vehicular traffic upstream of a parking lot exit which was constructed as a portion of the new California Public Employees Retirement System headquarters building. It will also control the anticipated additional pedestrian traffic generated because of the new building. The project has been proposed and is being financed by the California Public Employees Retirement System. The engineer's estimated construction cost is \$40,000.

FINANCIAL


The estimated total project cost, including all planning, design and construction costs, is \$52,000. No funds have been appropriated for this project, however the Public Employees Retirement System has deposited \$55,000 with the City of Sacramento to cover the cost of construction. It is proposed that the \$55,000 deposited by the State be appropriated from the General Fund for this project.

RECOMMENDATION


