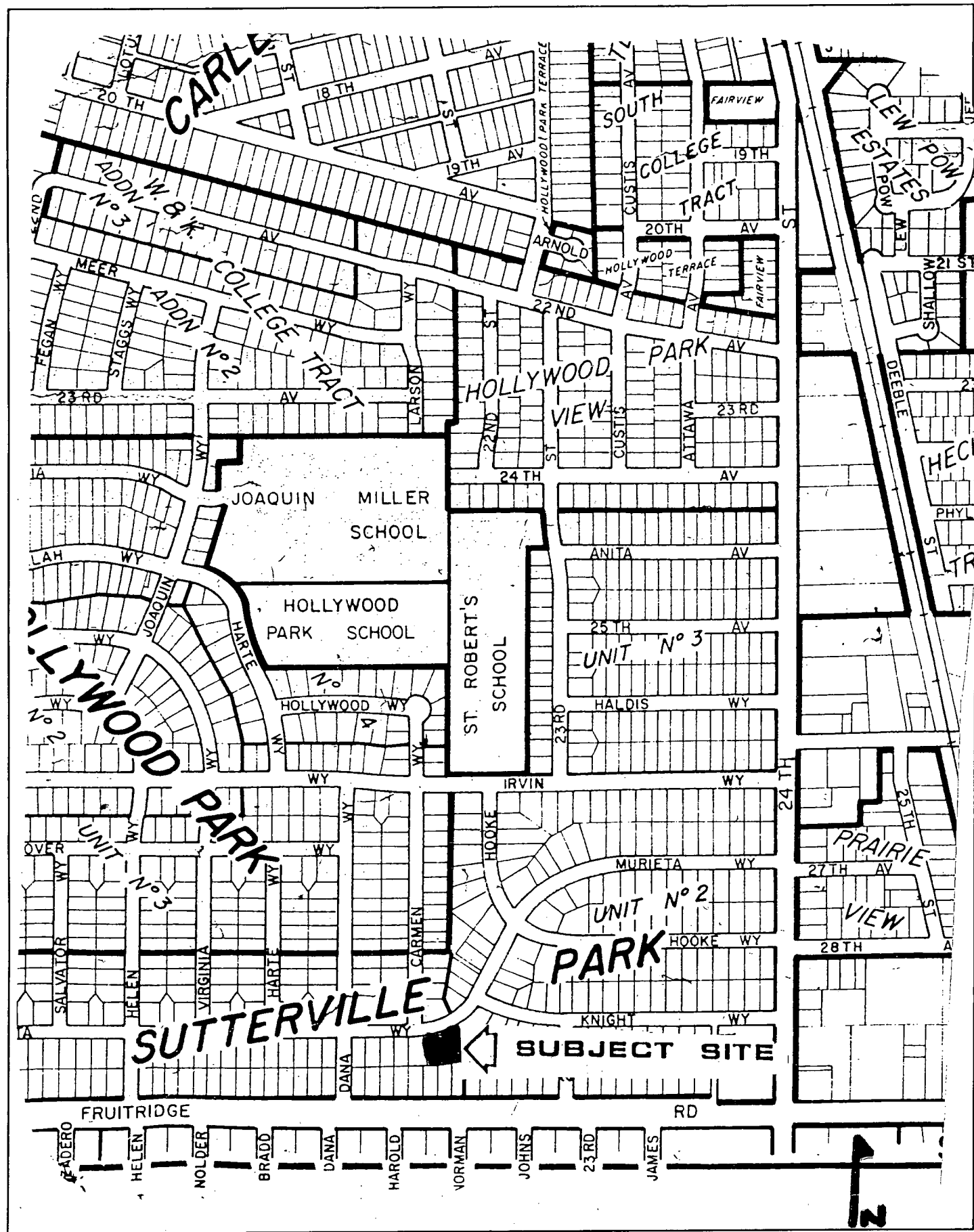

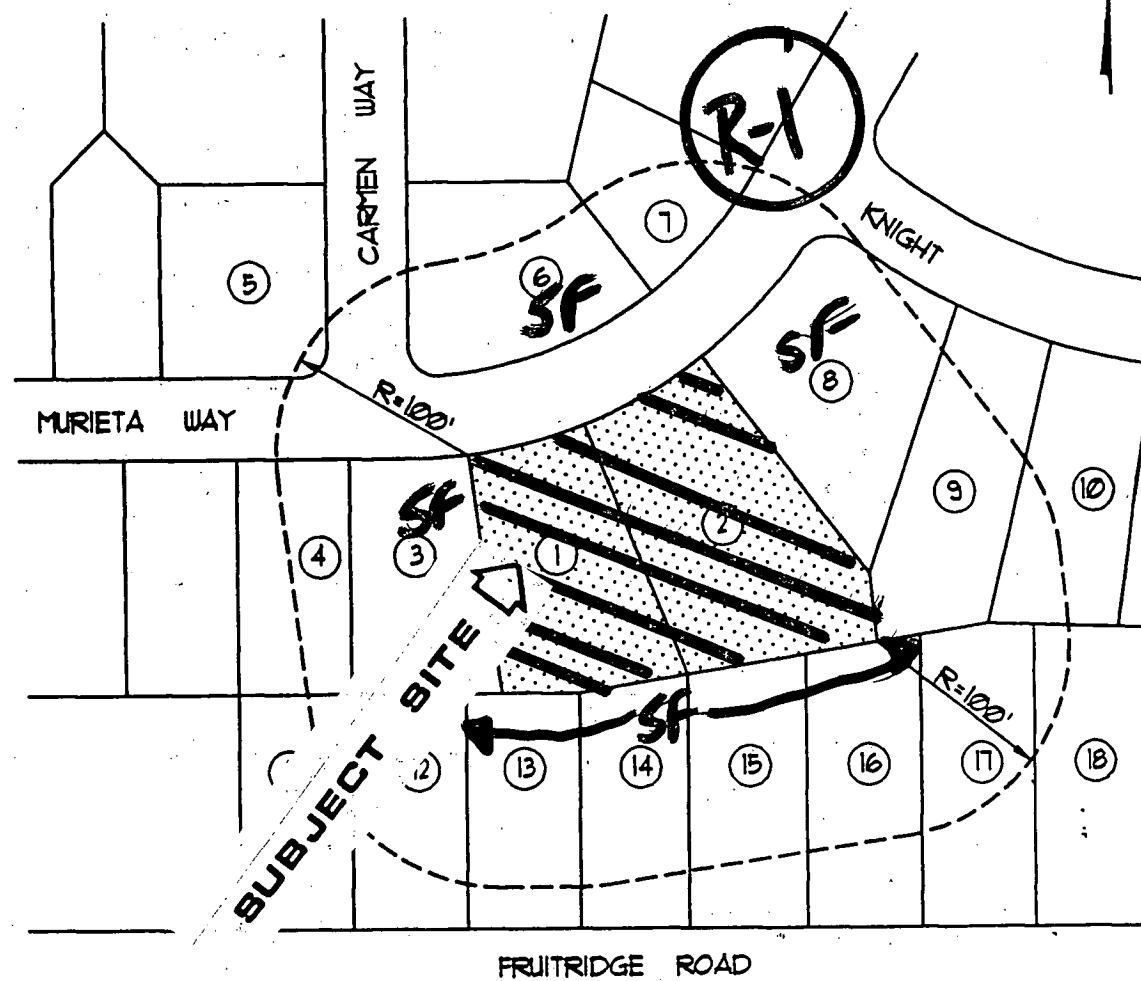

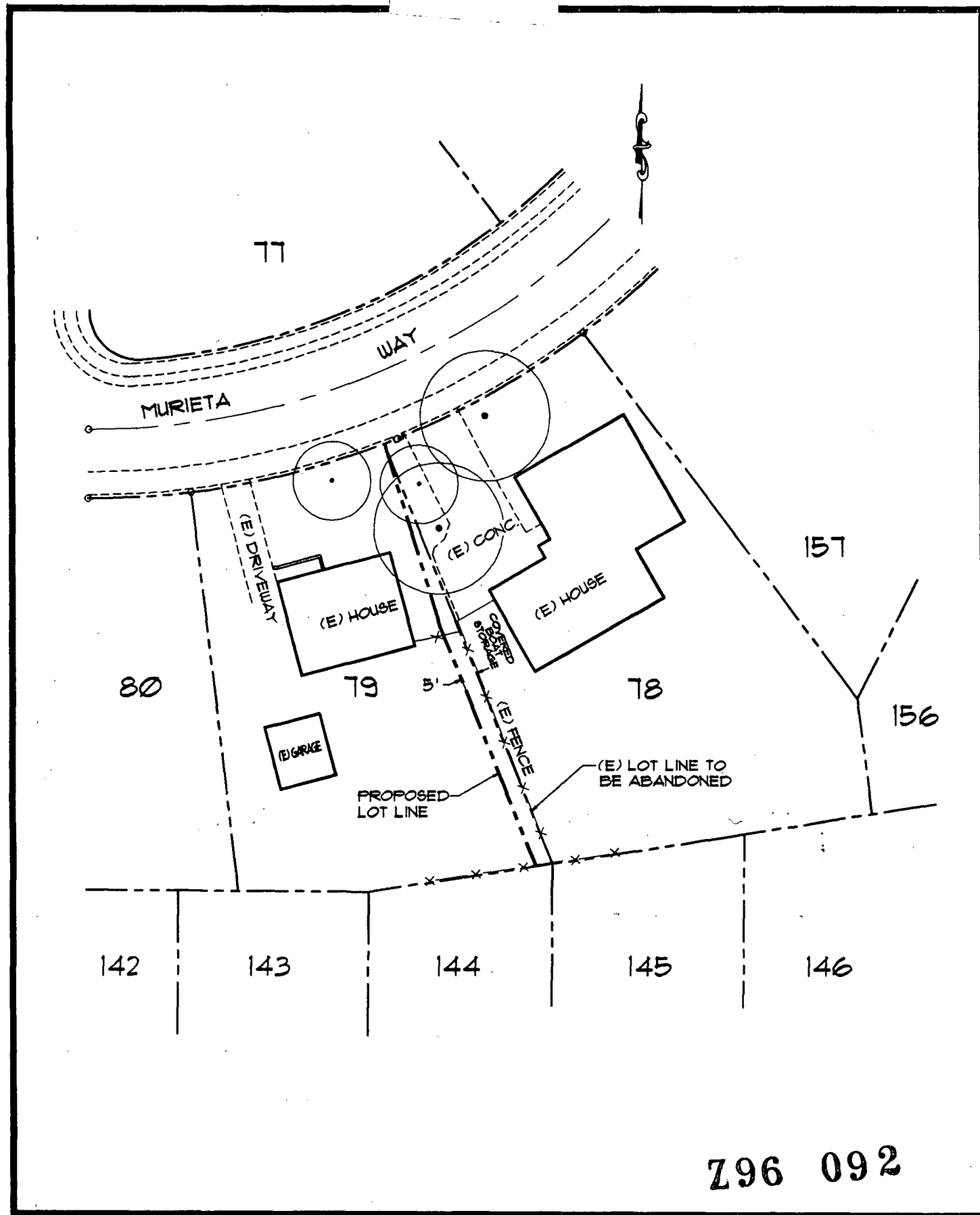


VICINITY MAP

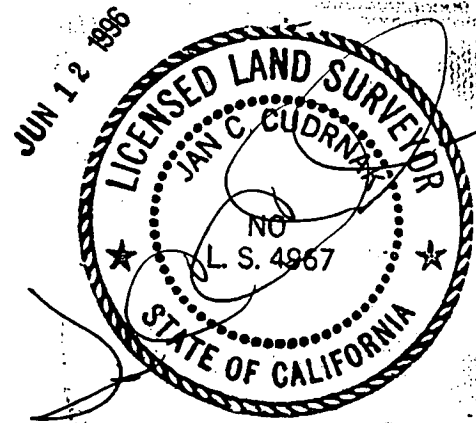

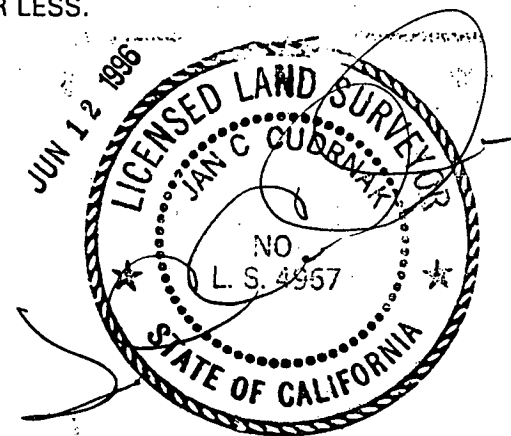
