SUBJECT:

- Emergency ordinance amending Title 25 of the Sacramento City Code relating to penalties, fines, fees and related charges for parking, traffic, and related violations
- Resolution to set parking fines, penalties, fees and charges

RECOMMENDATION:

This report recommends that the City Council:

- Adopt the attached City ordinance to grant authority to set parking fines, late penalties, administrative fees, and other related charges.
- Adopt the attached resolution establishing parking fines, late penalties, administrative fees and other related charges.

SUMMARY:

Assembly Bill 408 past by the State Legislature in the 1992 session requires that the schedule of parking fines, penalties, and fees be established by the governing body of the jurisdiction where the notice of violation is issued. AB 408 becomes effective July 1, 1993. After this date the parking fines set by the court are no longer valid. The report recommends that the City Council amend Title 25 of the Sacramento City Code relating to penalties, fines, fees and related charges for parking, traffic and related violations. This is an emergency ordinance to take effect immediately. The attached resolution sets the parking fees.

BACKGROUND INFORMATION:

Parking citations are currently processed and collected by the County Municipal and Superior Court. The Court sets the parking fines and penalties. Recent State legislation, Assembly Bill 408, takes parking fines out of the courts and gives the responsibility for administering and collecting parking fines to cities and other agencies as soon as possible, but no later than January 1, 1994. Cities must establish a schedule of parking fines, penalties, and administrative fees effective July 1, 1993.

In accordance with AB 408:

- The City, County, and Court are required to enter into an agreement for the orderly transfer of parking citation processing to the City no later than January 1, 1994;
- The City is authorized to contract with a private company for the processing of parking citations;
- The responsibility for conducting administrative hearings for contested parking citations is transferred to the City; and
- Schedules for parking fines, penalties, and fees shall be established by the governing body of the jurisdiction where the notice of violation is issued effective July 1, 1993.

An amendment to the City ordinance is required for City Council authority to set the schedule of parking fines, penalties, and fees. The attached emergency ordinance grants that authority. The attached resolution sets the parking fines.

The attached resolution establishes the schedule of parking penalties, late payment penalties, and administrative fees. This schedule reflects an increase over the current bail amounts to contribute to the offset of the 2.2 million shortfall in the Parking Fund Budget for the 1993-1994 Fiscal Year. Further offsets to the Parking Fund shortfall will be discussed in a forthcoming separate report to the City Council. All fines are increased by \$2.00 except the fine for truck parking in residential neighborhoods which is increased from \$14 to \$75 to provide a reasonable deterrent to this violation.

FINANCIAL CONSIDERATIONS:

Under existing legislation, the County receives 21% of parking citation revenue and 100% of the notice fees, and \$5 for every citation collected is distributed to County and State funds. With the new legislation the City is entitled to all revenues from parking citations, except for the amount distributed to County and State Funds. Parking citation revenue is deposited to the City's General Fund.

It is estimated that there will be an annual increase of \$336,000 from parking citation fines with the recommended schedule of fines, penalties, and administrative charges.

3. Parking Citation Penalty

Citations that are not paid in fifteen days from the date of issue are assessed a penalty of 100% of the original parking citation fine.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Chapter 25.16 is added to Title 25 of the Sacramento City Code, to read as follows:

Chapter 25.16. Penalties

- 25.16.501. Penalties, Fines, Fees and Related Charges for Parking, Traffic and Related Violations
 - (a) <u>Intent</u>.

It is the intention of the Sacramento City Council to exercise its full authority specified in California Vehicle Code Section 40203.5(a), by providing a procedure for establishment of a schedule of penalties for parking and related violations, late payment penalties, administrative fees, and other related charges for parking and related violations.

(b) <u>Procedure for Establishment.</u>

Subject to any limitations imposed by state law, the City Council shall, by resolution, establish penalties, fines, fees and related charges for parking and related violations, late payment violations, administrative fees and any other charge relating to the administration of the provisions of the California Vehicle Code specifying civil procedures for citation resolution, and booting and impounding of vehicles.

SECTION 2.

Title 25, Chapter 25.01, Section 25.07.107(c) is amended to read as follows:

25.07.107. Removal from street or immobilization of vehicles-when permitted; penalty.

(c) Violation of any provision of this chapter shall be subject to a civil penalty specified in the resolution adopted by the city council pursuant to Section 25.16.501.

SECTION 3.

Title 25, Chapter 25.10, Section 25.10.182 is amended to read as follows:

25.10.182. Penalty Provisions.

- (a) It shall be a violation of this chapter, unless expressly provided to the contrary herein, for any person to stand or park a motor vehicle contrary to the parking regulations established pursuant hereto. Said violation shall be subject to civil penalty as specified in the resolution adopted by the city council pursuant to Section 25.16.501;
- (b) It shall be unlawful and a violation of this chapter for a person to falsely represent himself or herself as eligible for a parking permit or to furnish false information in an application therefor to the Transportation Division. Said violation shall be punishable by a fine not to exceed \$500 or by imprisonment for a period not exceeding six (6) months, or both;
- (c) It shall be a violation of this chapter, unless expressly provided to the contrary herein, for a person holding a valid parking permit issued pursuant to this chapter, to permit the use or display of such permit on a motor vehicle other than that for which the permit is issued. Such conduct shall constitute a violation of this chapter both by the person holding the valid parking permit and the person who so uses or displays the permit on a motor vehicle other than that for which it is issued. Said violation shall be subject to civil penalty as specified in the resolution adopted by the city council pursuant to Section 25.16.501.

SECTION 4.

This ordinance is an emergency ordinance, to become effective immediately upon its adoption. The facts constituting the emergency are that under Chapter 1244, Statutes of 1992, as of July 1, 1993, parking and related violations are redesignated as civil matters instead of criminal matters, and that the civil penalties for violations must be established by the City Council, as the legislative body of the local agency which issues the notice of violation. Unless this ordinance becomes effective immediately, there will be no authority to adopt the required resolution establishing the civil penalties.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Chapter 25.16 is added to Title 25 of the Sacramento City Code, to read as follows:

Chapter 25.16. Penalties

- 25.16.501. Penalties, Fines, Fees and Related Charges for Parking, Traffic and Related Violations
 - (a) Intent.

It is the intention of the Sacramento City Council to exercise its full authority specified in California Vehicle Code Section 40203.5(a), by providing a procedure for establishment of a schedule of penalties for parking and related violations, late payment penalties, administrative fees, and other related charges for parking and related violations.

(b) Procedure for Establishment.

Subject to any limitations imposed by state law, the City Council shall, by resolution, establish penalties, fines, fees and related charges for parking and related violations, late payment violations, administrative fees and any other charge relating to the administration of the provisions of the California Vehicle Code specifying civil procedures for citation resolution, and booting and impounding of vehicles.

SECTION 2.

Title 25, Chapter 25.01, Section 25.07.107(c) is amended to read as follows:

25.07.107. Removal from street or immobilization of vehicles-when permitted; penalty.

(c) It shall be unlawful and a violation of this section for any person to drive or attempt to drive an immobilized vehicle, or to release or otherwise tamper with an immobilization device installed pursuant to this section. Violation of this section shall be an infraction, punishable as set forth in Section 1.01.070 of this code. Violation of any provision of this chapter shall be subject to a civil penalty specified in the resolution adopted by the city council pursuant to Section 25.16.501.

SECTION 3.

Title 25, Chapter 25.10, Section 25.10.182 is amended to read as follows:

25.10.182. Penalty Provisions.

- (a) It shall be unlawful and a violation of this article chapter, unless expressly provided to the contrary herein, for any person to stand or park a motor vehicle contrary to the parking regulations established pursuant hereto. Said violation shall be punishable by a fine not to exceed \$50 as established by the Municipal Court subject to civil penalty as specified in the resolution adopted by the city council pursuant to Section 25.16.501;
- (b) It shall be unlawful and a violation of this article chapter for a person to falsely represent himself or herself as eligible for a parking permit or to furnish false information in an application therefor to the traffic engineering office Transportation Division. Said violation shall be punishable by a fine not to exceed \$500 or by imprisonment for a period not exceeding six (6) months, or both;

- (c) It shall be unlawful and a violation of this article chapter, unless expressly provided to the contrary herein, for a person holding a valid parking permit issued pursuant hereto to this chapter, to permit the use or display of such permit on a motor vehicle other than that for which the permit is issued. Such conduct shall constitute an unlawful aet and a violation of this article chapter both by the person holding the valid parking permit and the person who so uses or displays the permit on a motor vehicle other than that for which it is issued. Said violation shall be punishable by a fine not to exceed \$50 as established by the Municipal Court subject to civil penalty as specified in the resolution adopted by the city council pursuant to Section 25.16.501.

- (e) It shall be unlawful and a violation of this article chapter for a person to copy, produce or otherwise bring into existence a facsimile or counterfeit parking permit in order to evade parking regulations applicable in a residential permit parking area. Upon conviction thereof, a the person shall be punishable by a fine not exceeding five hundred dollars (\$500.00) or be imprisoned for a period not exceeding six (6) months, or both.

SECTION 4.

This ordinance is an emergency ordinance, to become effective immediately upon its adoption. The facts constituting the emergency are that under Chapter 1244, Statutes of 1992, as of July 1, 1993, parking and related violations are redesignated as civil matters instead of criminal matters, and that the civil penalties for violations must be established by the City
