BACKGROUND INFORMATION

The Council awarded a contract to Granite Construction Company on April 17th, 1979 for constructing asphaltic concrete pavement, water distribution system complete, sanitary sewers, storm sewers and drainage facilities in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for January 26th, 1980. The work is finished but the quantities must be finalized and the assessment spread.
