SUMMARY

Bids were received from four (4) contractors and opened by the City Clerk on August 2, 2000. The low bidder was Sierra National Construction, Inc., with a bid of \$525,088. Sierra National Construction, Inc., exceeded the Emerging and Small Business Enterprise (ESBE) goals. It is therefore proposed to award the contract to Sierra National Construction, Inc., for \$525,088.

BACKGROUND INFORMATION

This project consists of removing existing 12, 18, 20 and 24-inch diameter combined sewer main and installing approximately 1650 linear feet of 15 to 36-inch diameter sewer pipe in 24th Street from S to W Street. As part of this project, all gutter drains, drain leads and manholes associated with this pipeline will be upgraded to current standards. Bids were received on August 2, 2000, and are summarized below:

- The Engineer's estimated construction cost was \$550,000.
- The estimated completion date is December 2000.

FINANCIAL CONSIDERATIONS

As of August 2, 2000, the unobligated balance available for this project (414/425-500-XM50-4820) is \$781,002. There are sufficient funds to award this construction contract and complete the project.

ENVIRONMENTAL DETERMINATION

The Planning Services Division, Environmental Section, has reviewed the project and has determined that this project is categorically exempt from CEQA under Section 15302(c) of the CEQA Guidelines. Trees along the pipeline will not be affected by construction.

This action is consistent with Chapter 58, Article III, Section 58.03.304 of the City Code concerning award of contracts.

ESBD CONSIDERATIONS

This project included participation goals of 20% for emerging and small business enterprises as required by Ordinance 99-007 and Resolution 99-055, relating to ESBD participation goals and policies, adopted by the City Council on February 9, 1999. The responsive low bidder, Sierra National Construction, Inc., exceeded the ESBE goals with a participation level of 20.47%.



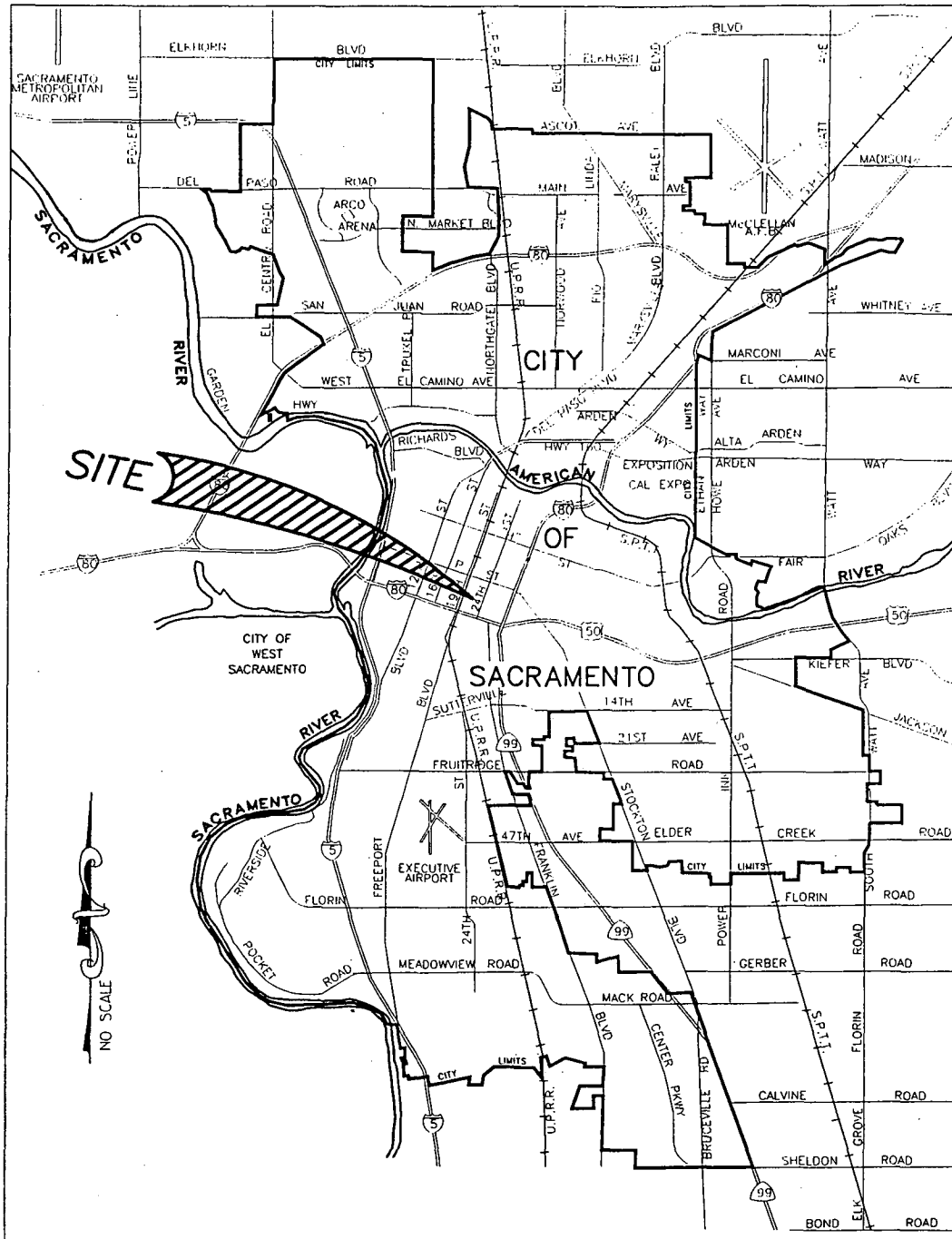

VICINITY MAP

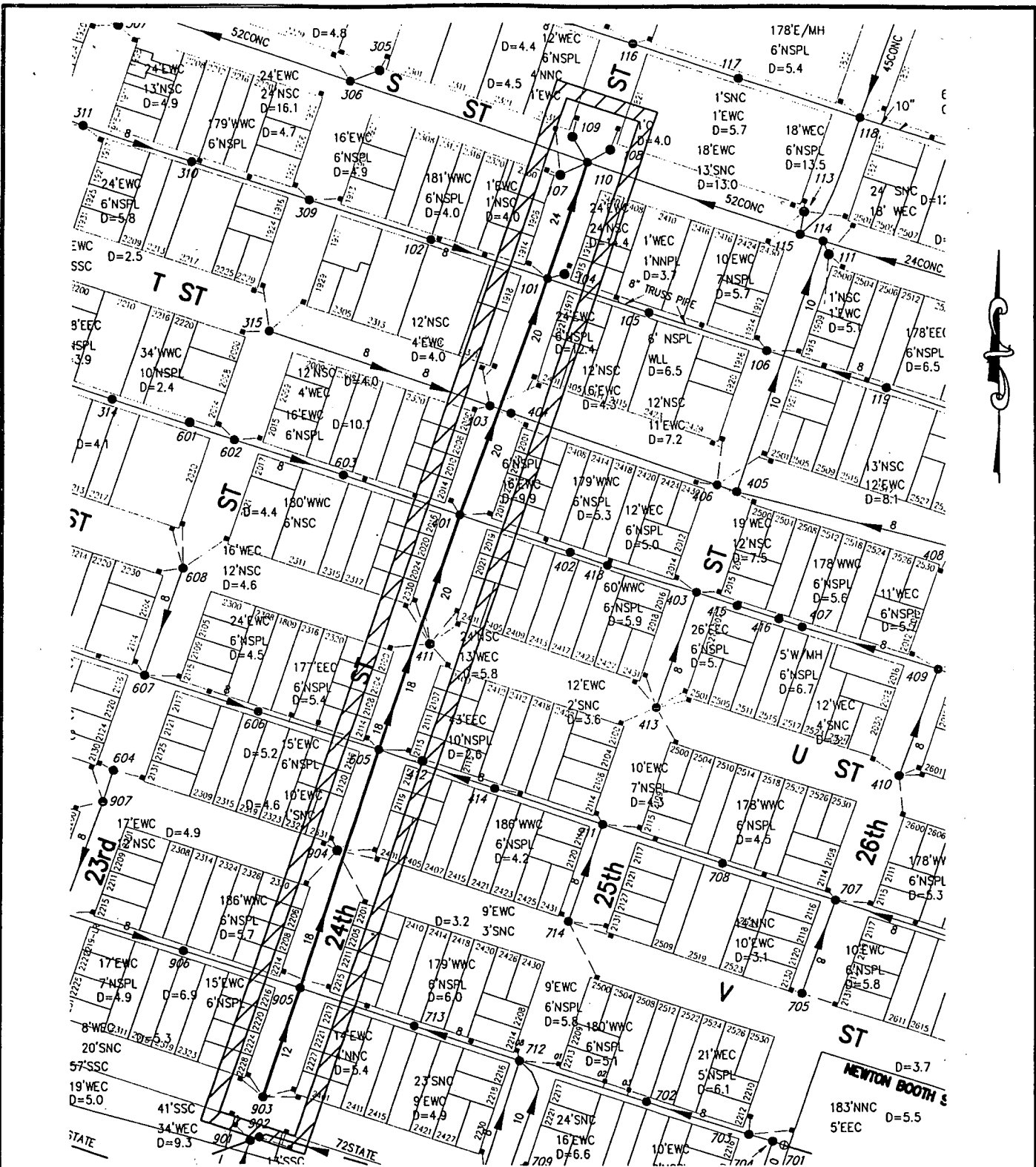
