

#### **Overall Sentiment**







SacACT supports City Council approval of Consent Item #3 scheduled for adoption on January 8. All of the concepts listed in the staff report to increase housing stock for those who are experiencing homelessness (sleeping cabins, transportable housing units, tents, and support facilities) are ones that Sacramento ACT supports and think should be Implemented.

The attached email letter to City Manager Chan and other City staff inquires about the linkage between the proposed ordinance and the duration of the previously adopted emergency shelter crisis declaration. Back and forth discussions with City staff about the concerns noted in this email letter confirm that the benefits of the relaxed building standards exist only during the period of the declared shelter crisis.

"Per our Chief Building Official, if the crisis declaration expires on March 1, 2019, the products approved under the amended ordinance (item #3 on tomorrow's Council agenda) must terminate being used." [Emily Halcon, email, 1/7/2019]

It would appear that very limited benefits can result from this proposed ordinance if the shelter crisis declaration is not extended past March 1, 2019.

Therefore, at the earliest possible date, SacACT urges the City Council to extend the end date of the emergency shelter crisis declaration so that the benefits of the relaxed building standards can be increased by allowing modifications to existing structures and construction of new facilities to expand housing capacity for homeless people.

Consent Item #3 on the posted agenda for the January 8, 2019 City Council meeting is proposed approval of an ordinance adopting portions of the State Building Code pertaining to reduced standards for structures intended for housing of people who are homeless. Sleeping cabins, transportable housing units, tents, and support facilities are cited as examples. The applicability of these reduced standards is limited to the period when a declared "State of Emergency, Local Emergency or Shelter Crisis" exists and for the duration of the declared housing crisis. All of the concepts listed to increase housing stock for those who are experiencing homelessness are ones that Sacramento ACT supports and think should be Implemented.

However, on November 8, 2018, the city Council adoption a shelter crisis declaration, but limited the period to be from 12/1/2018 to 3/1/2019. The Council did not respond to several requests (SacACT, Sacramento Regional Coalition to End Homelessness among others) that the end date be extended much further out in time.

The combination of the proposed ordinance and the term of the shelter crisis declaration appears to mean that the special provisions of the proposed ordinance for housing of people who are homeless will be in effect only from 1/9/2019 through 2/28/2018. Surely this seven-week period will have little, if any, impact on increasing housing for homeless people. This would make the proposed ordinance essentially useless.

Is there some other interaction between the provisions of the adopted shelter crisis declaration and the proposed ordinance that SacACT does not understand? Before making comments to the City Council, I would appreciate any effort by the City Staff to clarify our concern.
