## Description/Analysis

**Issue Detail:** On July 31, 2018, the Council voted to place Measure K (Sacramento City Charter Amendment and City Code Repeal Regarding the City Auditor) on the ballot, which was passed by the voters on November 6, 2018. Measure K amended the Sacramento City Charter to add the City Auditor as a charter officer; combined the duties of the City Auditor and the Independent Budget Analyst; and repealed the city code chapter related to the Independent Budget Analyst. The city auditor position becomes a charter officer effective July 1, 2019.

The incumbent City Auditor, Jorge Oseguera, was hired on May 3, 2010, and has been reporting directly to the Mayor and Council. The City Council unanimously selected Jorge Oseguera to continue in his role as City Auditor, now a charter officer, effective July 1, 2019.

**Policy Considerations:** The City Council alone is vested with the authority to appoint the City Auditor.

**Economic Impacts:** None

**Environmental Considerations:** Appointment of a City Auditor is considered an administrative activity by a governmental agency and does not constitute a “project” pursuant to Section 15378(b)(2) of the CEQA Guidelines and therefore is exempt from CEQA review.

**Sustainability:** There are no sustainability considerations associated with this report.

**Commission/Committee Action:** None

**Rationale for Recommendation:** The Council desires to appoint Mr. Oseguera to the position of City Auditor.

**Financial Considerations:** The City Auditor position is an existing budgeted full-time equivalent position and funding is available in the current budget. Mr. Oseguera is appointed as charter officer at his current salary, and he will receive the benefits to which the City Auditor is entitled pursuant to the Personnel Resolution Covering Unrepresented Officers and Employees.

**Local Business Enterprise (LBE):** No goods or services are being purchased.

### **APPOINTMENT OF JORGE OSEGUERA AS CITY AUDITOR**

#### **BACKGROUND**

- A. Pursuant to Sacramento City Charter sections 70 and 77, the City Council appoints the City Auditor.
- B. Based on his tenure, qualifications, and performance as the City Auditor under the Sacramento City Code, the City Council has selected Mr. Jorge Oseguera for the position of City Auditor under the Sacramento City Charter.
- C. The City Council desires to appoint Mr. Oseguera as the City Auditor, effective July 1, 2019.

#### **BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. Mr. Jorge Oseguera is appointed to the position of City Auditor.
- Section 2. The effective date of the appointment is July 1, 2019.
- Section 3. Mr. Oseguera will receive the benefits to which the City Auditor is entitled pursuant to the Personnel Resolution Covering Unrepresented Officers and Employees.
