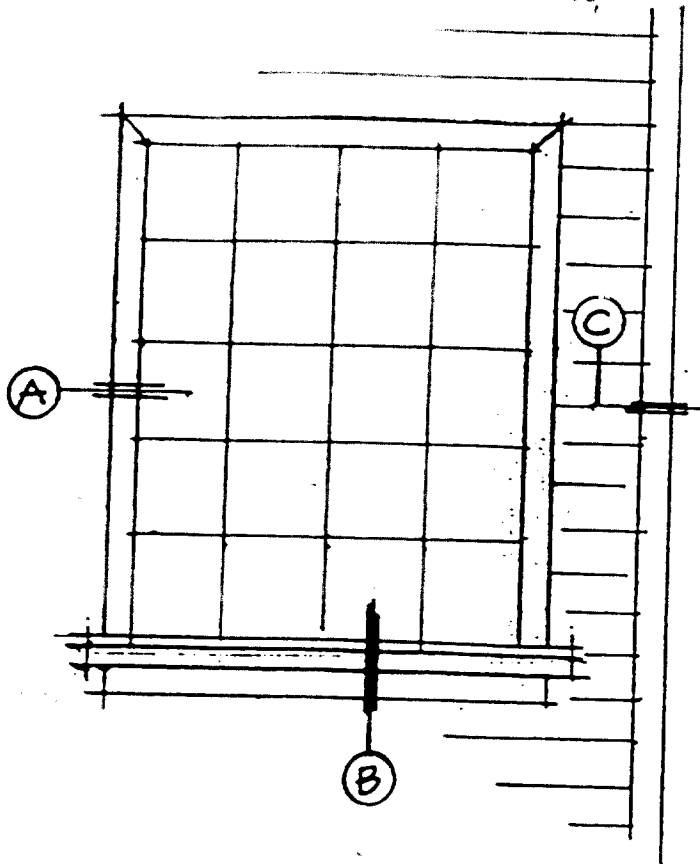

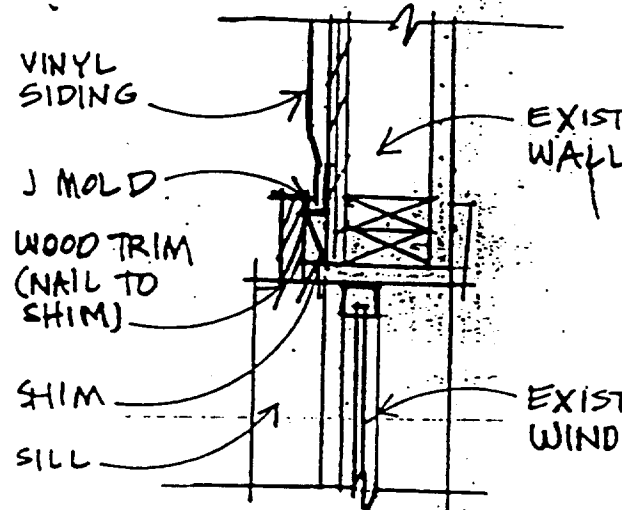

WOOD TRIM DETAILS WITH VINYL SIDING

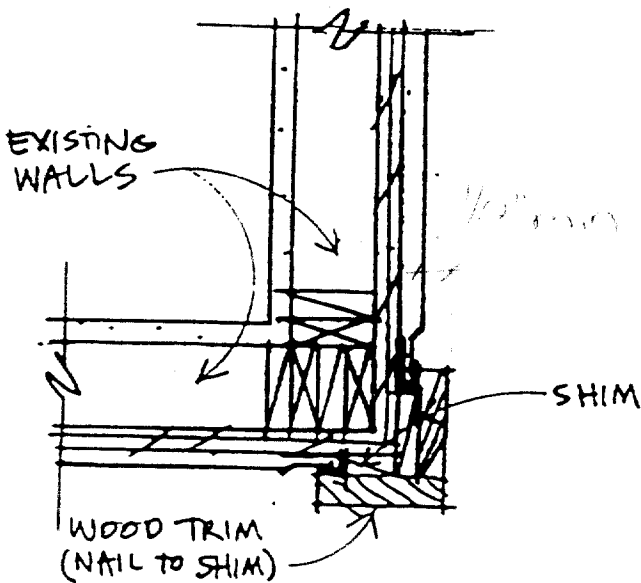


WINDOW ELEVATION

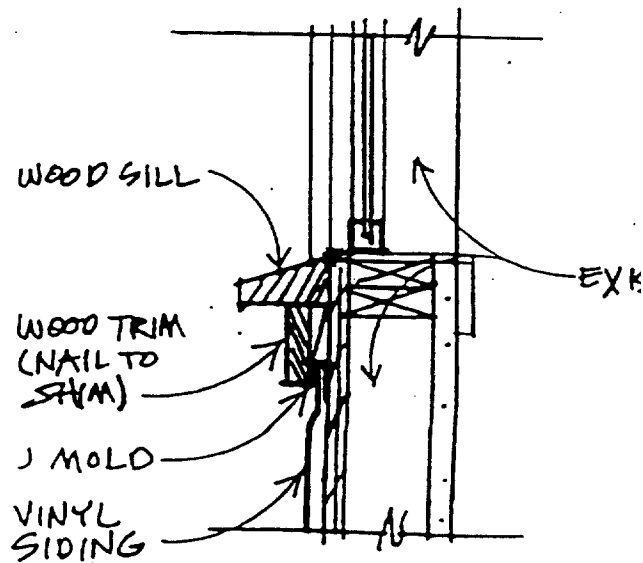
