SUBJECT: Metropolitan Arts Division--Authorization for City Manager to  
Execute Contract and Request for Increase in Appropriations

### SUMMARY

This report recommends authorizing the City Manager, on behalf of the Sacramento Metropolitan Arts Commission (designated local partner with the California Arts Council), to execute the contract between the State of California and the City of Sacramento to implement Phase II of the 1980-81 State/Local Partnership Program and to increase the FY 80-81 budget of the Metropolitan Arts Division by \$10,077.50.

### BACKGROUND INFORMATION

The California Arts Council and the State Legislature have established a State/Local Partnership Program consisting of two phases. Phase I provided a non-matching planning grant of \$12,000 to each County in the State for the purpose of developing a local arts plan. This phase was completed on March 24, 1981 when the City and County of Sacramento formally adopted the Arts Plan.

Phase II provides for a grant to implement the approved Arts Plan. On May 29, 1981, the California Arts Council approved the Arts Plan as submitted and awarded the Sacramento Metropolitan Arts Commission a grant in the amount of \$10,077.50 for arts programming in accordance with the State/Local Partnership Program Guidelines.

### FINANCIAL DATA


Based on formula funding, the Sacramento Metropolitan Arts Commission qualifies for a \$10,077.50 grant for the implementation phase. No significant indirect costs are associated with this grant and no additional City funds. The appropriation increase will be supported by State funds provided that the California Arts Council receives a signed contract and invoice by June 15, 1981.

RECOMMENDATION


It is recommended that the City Council adopt the following:

1. A resolution authorizing the City Manager, on behalf of the City of Sacramento, to execute the contract between the City and State of California, California Arts Council.
2. A resolution to increase appropriations to the Metropolitan Arts Division by \$10,077.50 for the purpose of implementing the 1980-81 State/Local Partnership Program.

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE THE CONTRACT ON BEHALF OF THE CITY OF SACRAMENTO WITH THE CALIFORNIA ARTS COUNCIL FOR THE 1980-81 STATE/LOCAL PARTNERSHIP PROGRAM

WHEREAS, the California State Legislature and the California Arts Council established the State/Local Patnership Program to encourage local arts and cultural planning and decision-making; and,

WHEREAS, in Fiscal Year 1980-81, \$12,000 was awarded and expended by the Sacramento Metropolitan Arts Commission to assist in the development of a comprehensive arts plan meeting the State/Local Partnership Program Guidelines for 1980-81; and

WHEREAS, the Board of Supervisors and the City Council of Sacramento have designated the Sacramento Metropolitan Arts Commission to direct and implement the State/Local Partnership Program sponsored plan development for Sacramento City/County for Fiscal Year 1980-81; and

WHEREAS, the Board of Supervisors and the City Council of Sacramento endorsed and approved the local arts plan developed on behalf of the City and County of Sacramento,

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the City Manager is hereby authorized to execute contract number Ac-0783 with the State of California in the amount of \$10,077.50 for the California Arts Council's State/Local Partnership Program.
