SUBJECT: Amendments to the City's Preferential Parking Ordinance

SUMMARY

This report recommends amendments to the City's Preferential Parking Ordinance to provide permit parking for property owners and to permit minor changes in Preferential Parking regulations without going through the entire designation process.

BACKGROUND INFORMATION

The current Preferential Parking Ordinance does not provide permit parking for non-resident owners of properties in Preferential Parking areas. Property owners occasionally need to park their vehicles on the street in such areas in order to service their properties. The attached Ordinance provides for "Property Owner Permits" for that purpose. Additionally, it provides for owners to obtain temporary permits for vehicles of commercial enterprises servicing such properties located in Preferential Parking areas (Example: Plumber, electrician, roofers, painters, etc).

The attached Ordinance also enables the City to make minor modifications to parking regulations in a designated Preferential Parking area without repeating the whole process of petitions, surveys and hearings. The amendment provides for such modification to be made by a Resolution of the City Council based on staff recommendation.

FINANCIAL DATA

The amendments of the attached Ordinance will not cause a financial impact.

RECOMMENDATION

It is recommended that the attached Ordinance amending the City's Preferential Parking Ordinance, as shown herein, be adopted.

AN ORDINANCE AMENDING ORDINANCE NO. 4155, FOURTH SERIES, SECTION 25.175 TO ADD PROVISIONS FOR PERMIT PARKING FOR OWNERS OF RESIDENTIAL PROPERTIES THAT ARE LOCATED IN RESIDENTIAL PERMIT PARKING AREAS; AND AMENDING SECTION 25.176 TO ADD PROVISIONS FOR VISITOR PERMITS FOR OWNERS OF RESIDENTIAL PROPERTIES THAT ARE LOCATED IN RESIDENTIAL PERMIT PARKING AREAS; AND ADDING SECTION 25.185 TO ADD PROVISIONS FOR MODIFICATION OF PREFERENTIAL PARKING REGULATIONS IN RESIDENTIAL PERMIT PARKING AREAS.

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

Sec. 25.175 Issuance of Permits is hereby amended to add the following:

- (5) An owner of residential property that is located within the residential permit parking area.

Sec. 25.176 Visitor Permits is hereby amended to read:

The Traffic Engineer is authorized upon application to issue visitor parking permits to residents and owners of residential properties that are located within a residential permit parking area for use of bona fide transient visitors therein. Such a visitor permit shall have all the rights and privileges of a regular permit. The requirements governing the manner in which persons shall qualify for visitor permits in each residential permit parking area shall be established by resolution of the City Council. The Traffic Engineer shall recommend appropriate requirements in each area.

Sec. 25.185 Modifications of Regulations is hereby added to read as follows:

On-street parking regulations within a residential permit parking area may be changed by resolution of the City Council based on recommendation by the City Traffic Engineer.
