**SUBJECT: APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID AND CONTRACT AWARD FOR DOS RIOS STREET RECONSTRUCTION (PN: TT21) IN THE AMOUNT OF \$465,739.**

**LOCATION AND COUNCIL DISTRICT:**

Dos Rios Street between Richards Boulevard and North 12/ North B Street, Council District 1

**RECOMMENDATION:**

This report recommends that the City Council:

- Approve plans and specifications;
- Accept the bid of Baldwin Contracting in the amount of \$465,739; and
- Authorize the City Manager to execute a contract for Dos Rios Street Reconstruction Project (PN:TT21).

**SUMMARY:**

This project will improve Dos Rios Street between Richards Boulevard and North 12/North B Street. The improvements include construction of asphalt concrete pavement, replacement

of damaged curb, gutter, and sidewalk and installation of storm drainage and sewer system. The purpose of the project is to improve drainage in the area and improve the overall aesthetics in the area.

**COMMITTEE/COMMISSION ACTION:**

None.

**BACKGROUND INFORMATION:**

- This project was authorized in the 1998/1999 Capital Improvement Program.
- This project was advertised and bids were received on February 16, 2000 and are summarized below:

- The engineer's estimated construction cost was \$504,193.
- Approval of the plans and specifications and award to Baldwin Contracting is recommended.

**FINANCIAL CONSIDERATIONS:**

- The unobligated fund balance as of March 2, 2000 is \$534,281, which is sufficient for award.


**POLICY CONSIDERATIONS:**

**ESBD CONSIDERATIONS:**

To encourage small and emerging business participation, plans and specifications were sent to 8 plan rooms and construction service organizations for publication. All are directly involved with ESBE construction firms. Staff actively recruited available ESBE firms to participate in the bid process. Project notices were sent to 30 organizations involved in ESBE recruitment. The project was also announced on the Project Information Line and on the City's Internet site at [www.sacto.org/bids](http://www.sacto.org/bids).


