SUBJECT: 1988 Per Capita Grant- Change in Projects for FY 1991-92

SUMMARY

This report provides information on the previously approved FY 1991-92 projects to be funded under the 1988 Bond Per Capita Grant Program. In addition, this report requests that City Council, by resolution, approve a change in the scope of the Science Center project to renovate the exterior habitat exhibition at the Science Center.

BACKGROUND

On December 6, 1988, City Council approved a three year program of grant funding under the 1988 Park Bond Act Per Capita grant program. Project funding requests were submitted for the FY 1989-90 and FY 1990-91 and were approved by the State Department of Parks and Recreation.

Staff will be submitting funding requests for the approved FY 1991-92 projects. These projects include: 1) Renovation of the Science Center's animal hall; 2) Replacement of the fiberglass at Sim Pool; and 3) Phase 1 development of Belle Coolege Park.

Staff is recommending that the project to renovate the animal hall at the Science Center be changed. Funding sources originally identified to fund the project are not available at this time. Staff recommends that the project be changed to the renovation of the exterior habitat exhibition. The habitat area is presently utilized for a variety of guided educational programs, including tours serving approximately 20,000 school children annually. The proposed renovation would enhance the existing guided tours and also provide self-guided opportunities.

The project would include: (1) interactive interpretive signage, (2) pathways to currently inaccessible features such as the pond, birdblind, and a redwood grove; and (3) picnic tables, benches, and trash receptacles.

FINANCIAL DATA

The City of Sacramento has been allocated \$212,000 for FY 1991-92 in grant funding. The change in the Science Center project will not necessitate the use of City funds.

No City funds are requested.

POLICY CONSIDERATIONS

A revised resolution is necessary to complete the grant application for the FY 1991-92 projects.


MBE/WBE EFFORTS

Every effort will be made to support the City's MBE/WBE goals.


RECOMMENDATION

WHEREAS, the people of the State of California have enacted the California Wildlife, Coastal, and Park Land Conservation Act of 1988, which provides funds to the State of California and its political subdivisions for acquiring and/or developing facilities for public recreational and open space purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of application(s) before submission of said application(s) to the State; and

WHEREAS, said application(s) contain assurances that the applicant must comply with; and

WHEREAS, the applicant will enter into an agreement with the State of California for acquisition or development of the project(s);

1. Approves the filing of an application for the Per Capita Grant Program under the California Wildlife, Coastal, and Park Land Conservation Act of 1988 state grant assistance for the above project(s); and
2. Certifies that said applicant understands the assurances and certification in the application form; and
