

RESOLUTION OF PRELIMINARY DETERMINATION OF LEGISLATIVE BODY
UNDER "SPECIAL ASSESSMENT INVESTIGATION, LIMITATION AND
MAJORITY PROTEST ACT OF 1931" NO. 2517

BE IT RESOLVED by the City Council of the City of Sacramento that certain improvements are proposed to be done and made within the boundaries of the proposed assessment district hereinafter described.

In connection therewith, said City Council hereby finds and determines as follows, to-wit:

1. That the nature of the proposed improvement and the location and extent thereof consists of improving the alley between "O" and "P" Streets from the easterly line of 22nd Street to the westerly line of 23rd Street; by removing and disposing of all refuse and surplus material; installing cast iron gutter drains and connecting same to sewer system with vitrified ironstone pipe sewer; reconstructing existing manhole by placing curb and cover to proper grade constructing vitrified ironstone pipe sewer; grading and constructing an hydraulic concrete pavement six (6) inches in thickness.

Cast iron gutter drains shall be as shown on Cut No. 11 of said specifications.

Sewer joints shall be made with G.K. sewer joint compound as specified in Section 13 of said Specifications.

Hydraulic concrete pavement shall be Class "D" concrete as specified in Section 26 of said Specifications, and made with high, early-strength, Portland Cement as shown in Section 25 of said Specifications and otherwise constructed in accordance with Section 27 of said Specification.

2. The boundaries of the district of lands proposed to be specially assessed to pay the costs and expenses of such proposed work and improvement are generally defined as follows, to-wit:
Commencing at a point on the easterly line of 22nd Street 40 feet north from the northerly line of said alley; thence easterly on a right angle and parallel to the northerly line of said alley 80 feet to a point on the westerly line of Lot #2 in the block bounded by O-P-22nd-23rd Streets; thence northerly along the westerly line of said Lot #2 to the southerly line of O Street; thence easterly along the southerly line of O Street to a point 13 feet east of the north east corner of Lot #3 in the said block; thence southerly on a line

parallel to the easterly line of said Lot #3 to a point 40 feet north of the northerly line of said alley; thence easterly on a right angle and parallel to the northerly line of said alley to a point on the westerly line of 23rd Street; thence southerly on the westerly line of 23rd Street to a point 40 feet south of the southerly line of said alley; thence westerly on a right angle and parallel to the southerly line of said alley to a point on the easterly line of Lot #6 in the said block; thence southerly on the westerly line of said Lot #6 to the northerly line of P Street; thence westerly on the northerly line of P Street to the easterly line of 22nd Street; thence northerly along the easterly line of 22nd Street to the point of beginning;


3. That the amount and portion of the cost of such proposed improvement proposed to be paid by the City of Sacramento from any source other than special assessments upon benefited property is nil.

4. The statute under which it is proposed to conduct proceedings for the proposed improvement is Division 7 of the Streets and Highways Code, the "Improvement Act of 1911;" with bonds to be issued as authorized under Division 10 of the Streets and Highways Code, the "Improvement Bond Act of 1915;" said bonds to bear interest at the rate of five (5%) per cent per annum.

RESOLUTION DETERMINING INITIAL VIEW
OF LEGISLATIVE BODY THAT DEBT LIMITA-
TION WILL NOT BE EXCEEDED NO. 2517
