**SUBJECT: SUSPENSION OF FORMAL COMPETITIVE BIDDING FOR THE
PURCHASE OF A REPLACEMENT PUMP IMPELLER FOR SUMP NO. 2**

LOCATION AND COUNCIL DISTRICT: City-wide-All Districts

RECOMMENDATION:

It is recommended that, in the best interest of the City, the City Council adopt the attached Resolution which authorizes the suspension of formal competitive bidding for the purchase of a replacement pump impeller for Sump No. 2, and authorizes the City Manager to issue the necessary purchase order to Ingersoll Dresser Pump Company in a total amount not to exceed \$56,750.00.

SUMMARY:

This report requests that City Council authorize the suspension of formal competitive bidding for the purchase of a replacement pump impeller from Ingersoll Dresser Pump Company.

BACKGROUND INFORMATION:

The Plant Services Division of the Utilities Department has a requirement for a replacement pump impeller for Sump No. 2, as authorized by the City Council in C.I.P. No. WC61.



The large capacity pumps located at Sump No. 2 were manufactured by the Worthington Pump Company. This replacement impeller is available only from Worthington, the original equipment manufacturer, and is sold through their sole territorial distributor, Ingersoll Dresser Pump Company. The total cost, including tax and freight, is \$56,750.00.

FINANCIAL CONSIDERATION:

Funds for this equipment are available in C.I.P WC61, "Drainage Sump No. 2 Modifications", with a remaining balance of \$131,741.00.

ENVIRONMENTAL CONSIDERATION:

Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or materials which are not made for purposes of a public works construction project, do not constitute a "project" and are exempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 15378(b)(3).


POLICY CONSIDERATIONS:

This recommendation is in accordance with the provisions of City Code Section 57.04.401(c), which authorizes suspension of formal competitive bidding upon a two-thirds vote of the City Council.

MBE/WBE EFFORTS:

Ingersoll Dresser Pump Company is not an M/WBE firm. As this is a sole source item, it is not available from M/WBE firms.
