

Sacramento, California,

May 5, 1930.

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:00 o'clock P. M., President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman and Chenu.
ABSENT : None.

The minutes of the special meeting of April 7, 1930, were read and approved as read.

The Board discussed the action taken in the Culbertson case at their meeting of April 7, 1930. Commissioner Chenu relinquished the Chair to Commissioner Weisman.

Commissioner Chenu moved that the action taken by the Board at their meeting of April 7, 1930, relative to the case of H. W. Culbertson be rescinded . There was no second to the motion.

Commissioner Chenu moved that Mr. F. N. Evans, Superintendent of Parks, be requested to appear before the Board. The motion was seconded by Commissioner Maloney. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

Commissioner Weisman relinquished the Chair to Commissioner Chenu.

Commissioner Weisman moved that Rule 8, Section 1, be amended by the addition of the following provision and spread upon the minutes to be called by the Board at a meeting in conformity with Rule 10, Section 4:

" No person holding a position with the City under temporary appointment shall be granted a leave of absence for any period."

The motion was seconded by Commissioner Maloney. The vote was

as follows:

The Secretary was instructed to insert the foregoing amendment in its proper place.

The Board next considered the communication from City Manager James S. Dean dated March 27, 1930, relative to the case of Mrs. Lillian Beilby, wherein the Board was requested to reconsider the decision rendered at their meeting of March 17, 1930. Commissioner Maloney moved that the City Manager be advised that under Section 43 of the Charter and the Civil Service Rules that it was impossible to comply with the request. The motion was seconded by Commissioner Weisman. The vote was as follows:

Commissioner Weisman moved that Rule 8, Section 1, be amended by the addition of the following provision and spread upon the minutes to be called by the Board at a meeting in conformity with Rule 10, Section 4:

" No request for reinstatement shall be considered if the person applying shall have been out of employment with the City for a period exceeding one year."

The motion was seconded by Commissioner Maloney. The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.
NOES: None.

Commissioner Maloney moved that the request of Judge L. M. Shelley, before the Board March 17, 1930, and laid over, be denied and a communication directed to Judge Shelley advising him that his request was denied. The Secretary was instructed to enclose a copy of the eligible list for stenographer.

A report of a leave of absence for 90 days for Mrs. Linna Low was next given consideration. Commissioner Maloney moved that Mrs. Low be granted a leave of absence for 90 days to visit the burial place of her son. And, further, that Mrs. Low's rights to her position should not be in jeopardy. The motion was seconded by Commissioner Weisman. The vote was as follows:

The Board next gave consideration to the proposed examination for Senior Clerk. Commissioner Maloney moved the approval of the examination presented for review. The motion was seconded by Commissioner Weisman. The vote was as follows:

Commissioner Weisman moved that applications be received from May 6, 1930, until May 15, 1930, at 5:00 o'clock P. M. and that the examination be held May 19, 1930, at 7:00 o'clock P. M. The motion was seconded by Commissioner Maloney. The vote was as follows:

NOES: None.
