

Sacramento, California,

April 10, 1931.

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:00 o'clock P. M. in the office of the Board, Room 106 City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman, and Chenu.

ABSENT : None.

A committee from the Municipal Employees Association of the City of Sacramento appeared before the Board. The committee was composed of Mr. Gardiner, Mr. Rawle, Mr. Burroughs, and Mr. Quillinan. The Board discussed with the committee several questions in the questionnaire recently distributed, and allowed an extension of time until May 1, 1931, for the completion of the questionnaire.

W. E. Phillips, an eligible on the Carpenter's eligible list, appeared before the Board requesting information relative to the status of those at present on the eligible list, and whether they would be required to submit to a new examination. Mr. Phillips was informed that he would be notified of any decision the Board might render relative to the eligible list in question, and that he would receive notice concerning any examination that might be held.

The Board discussed the positions of battery man and washer. The Secretary was instructed to call eligibles from the Laborer's list and determine their qualifications.

A communication was received from William Peck, requesting reinstatement to his position as elevatorman with the City. Mr. Peck was away on leave due to an accident since September 27, 1930.

Commissioner Maloney moved that action be deferred in this case and more data obtained. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.  
NOES: None.

Commissioner Maloney moved that a communication be directed to the City Manager requesting that foremen be advised to assist employees in the preparation of their questionnaires to the extent of defining the questions, and advising of the extension of time granted to complete the questionnaire. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.  
NOES: None.

The committee appointed by the President of the Board to prepare an examination for Secretary of the Board had no report to submit.

The Board gave consideration to the separation of R. V. Wise as Truck Driver and his subsequent appointment as Tractor Operator, also the retention of the classification of Mechanic.

Commissioner Maloney moved that a letter be directed to the City Manager, advising that it was the sense of the Board that cooperation was not being received from the departments concerned with reference to the classification of Mechanic and Truck Driver. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.  
NOES: None.

Adjournment was taken at 10:00 o'clock P. M. to meet again at the call of the Chair.
