

Sacramento, California.

June 26, 1930,

The Civil Service Board of the City of Sacramento met in special session on the above date at 4:30 o'clock P. M. in the office of the Board, Room 106 City Hall, Vice-President Weisman presiding.

PRESENT: Commissioners Maloney and Weisman.
ABSENT : Commissioner Chenu.

The minutes of the special meetings of May 22, 1930, and June 12, 1930, were read and approved as read.

The case of Bernice K. Burt was presented to the Board. The opinion requested by the Board, from the City Attorney, relative to this case was read. Commissioner Maloney moved that the complete record in this case with the opinion be filed. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

A communication was read from Joseph Nusbaum requesting an extension of leave of absence for Peter J. Nusbaum. A letter from Dr. J. Howard Hall accompanied this request. Commissioner Maloney moved that Mr. P. J. Nusbaum be given an additional leave of absence of six months beginning April 3, 1930. This motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

The Secretary submitted the budget for the Civil Service Department for the fiscal year 1931 to the Board for their approval. Commissioner Maloney moved that the Board adopt the budget as submitted by the Secretary. This motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
NOES: None. ABSENT: Commissioner Chenu.

A communication was read from George Deasy requesting that his name be restored to the laborers eligible list. The Secretary explained to the Board the circumstances surrounding Mr. Deasy's failure to report on the job after he had been certified to the position. After discussing this case, Commissioner Maloney moved that this request be denied. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
 NOES: None. ABSENT: Commissioner Chenu.

A communication was received from Robert Boyack requesting his reinstatement in the service of the City. The Secretary explained to the Board that Mr. Boyack had been discharged by the head of the department in which he was employed for reasons which the department considered sufficient. Commissioner Maloney moved that the Secretary be instructed to notify Mr. Boyack that the Civil Service Board had no jurisdiction over this case. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney and Weisman.
 NOES: None. ABSENT: Commissioner Chenu.

The pay roll for the Civil Service Department and the Pension roll were submitted to the President for his signature.

Adjournment was taken at 5:15 o'clock P. M. to meet again at the call of the Chair.
