SUBJECT: SUMP 90 IMPROVEMENTS (PN: WG11) REJECTION OF BIDS

LOCATION AND COUNCIL DISTRICT:

The project is located at Sump 90 approximately one-half mile south of the town of Freeport on the east side of the Sacramento River, adjacent to Highway 160 and serves Council Districts 7 and 8 (see location map).

RECOMMENDATION:

Staff recommends that the City Council reject all bids for the Sump 90 Improvements Project so staff can redesign and rebid the project.

BACKGROUND INFORMATION

Sump 90 is a drainage pump station which pumps drainage water from Morrison Creek into the Sacramento River. During high flows, a small quantity is also derived from the Cosumnes and Mokelumne Rivers.

The following is a list of proposed improvements and the corresponding purpose of these improvements:

- Addition of a smaller low flow pump to reduce power demand and increase efficiency.
- Concrete lining in the channel and construction of a ramp in front of the station to allow for easier debris removal.
- Modifications to the existing outlet in the Sacramento River to stabilize the outfall and dissipate excessive velocities which create a public safety hazard.

The estimated construction cost for this project was \$300,000. Bids were received from three (3) contractors as shown below:

• LM Construction	\$ 408,574
• IAS Construction, Inc.	\$ 482,884
• HK Merron Construction, Inc.	\$ 575,431

All bids were over the projected project cost estimate, including contingencies. The project will be modified and changes made to decrease the overall project costs to allow it to be built more closely to the original project costs.

FINANCIAL CONSIDERATIONS

This action will have no financial impact; however, funds are available in the Sump 90 Improvements Project (WG11) when it is rebid.



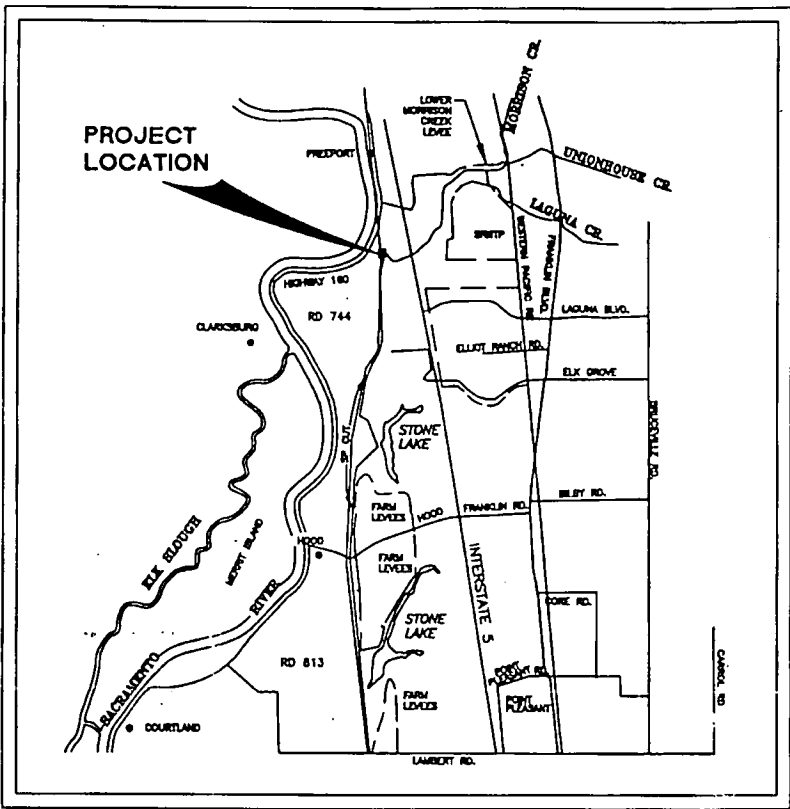

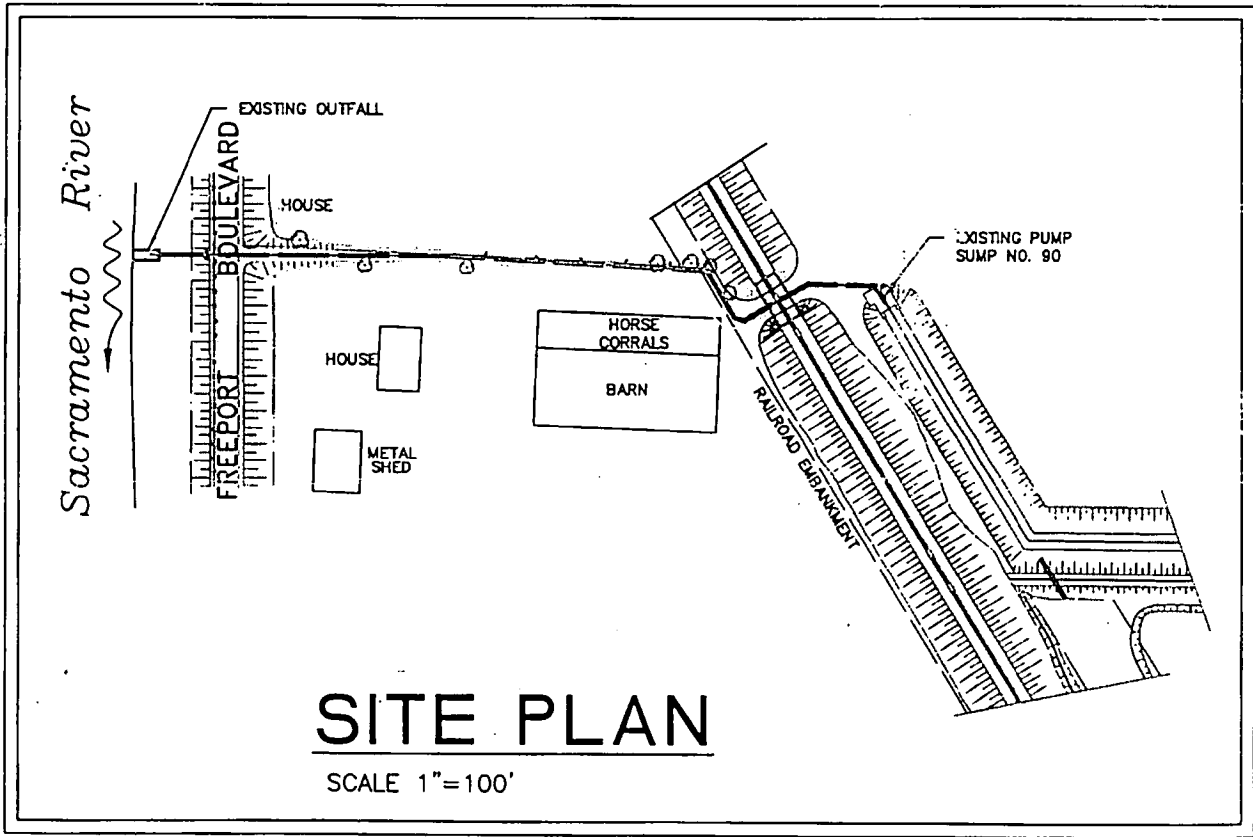

LOCATION MAP

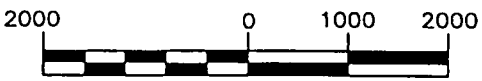
SCALE 1"=2,000'
