

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING

October 16, 1936.

The Civil Service Board met in special session in the office of the Board at 8:15 P.M., President Chenu presiding.

PRESENT: Commissioner Stacy and President Chenu.
ABSENT : Commissioner Deise

The minutes of September 23, 1936 and October 2, 1936 were approved as read.

UNIFORM FIREMAN EX. #90

Pease, Wyman

Mr. Pease appeared before the Board requesting information relative to securing Veteran's

Credit, which he felt should be added to his grade received in the Uniform Fireman Exam. #90. Mr. Pease presented his discharge from the United States Naval Reserve Force as well as a letter from Brigadier General H. H. Morehead dated August 27, 1936, stating that Mr. Pease had enrolled at the Navy Recruiting Station in San Francisco October 19, 1918 and held a rating of Apprentice Seaman at the time of his discharge December 14, 1918. After discussion, the Board requested the Secretary to secure information from the Commandant of the Naval Reserves at San Francisco as to whether Mr. Pease would have been returned to the Navy as a Seaman in the event he failed to successfully pass the Officers' Training School course for which he enrolled.

DATES OF APPOINTMENT

A letter from Mr. Roy W. Blair dated October 10, 1936 pertaining to the appointment of Miss Lee King and Miss Claire King as

employees of the California National Bank was read by the Board.

In his letter Mr. Blair stated that Lee King started to work for the City Treasurer July 1, 1921, and that Claire King was first employed by the City Treasurer on or about December 15, 1923, and that salaries of both employees were paid by the California National Bank until some time in 1926. The Secretary presented records secured from payrolls indicating that Lee King was first employed and paid by the City July 1, 1926, and that Claire King was first paid by the City March 1, 1926. Claire King was employed until June 30, 1926, after which time she was not paid for a period of ten months. Since May 1, 1927, (at the conclusion of the ten month period) she has been paid regularly by the City.

After discussion, it was agreed and ordered by the Board that Claire King's date of appointment should be March 1, 1926, and Lee King's date of appointment should be July 1, 1926.

Information secured from payroll records indicate that Chester Williams was first employed November 1, 1923 instead of March 5, 1924. After discussion, Commissioner Stacy moved that his date of appointment be changed to November 1, 1923. Seconded by Commissioner Chenu and unanimously carried.

After reviewing Mr. Foster's examination paper and ordering that no change be made in his grade, it

was agreed and ordered that the Tentative Eligible Register as shown in the minutes of August 27, 1936, be established and effective as of October 20, 1936, the motion being made by Commissioner Stacy, seconded by Commissioner Chenu, and carried with the following vote:
