

ATTACHMENT 1

Background:

The Maddy Act (Government Code 54970) requires that, on or before December 31st of each year, a list be prepared showing which City appointed board, commission and committee positions expire in the next calendar year. This list (Attachment 2) must include which terms will expire, the name of the incumbent, the date of term expiration, and the qualifications for the position.

As noted in the Maddy Act, this information is made available in order to tap into the talent which exists among the citizenry who are too frequently not aware of the opportunities for participation on local advisory boards, commissions and committees.

This list is also available in the Office of the City Clerk, on the City's web page at [http://www.cityofsacramento.org/clerk/boards and commissions/](http://www.cityofsacramento.org/clerk/boards_and_commissions/) and provided to the downtown library.

To further announce openings as they occur, an item is placed on the City Council agenda seeking approval to open the application period, individual announcements are available in the Office of the City Clerk, on the City's web page as noted above, and sent to various libraries. Metro Cable Channel 14 also displays the open application periods (throughout the year) when not broadcasting scheduled events.
