SUMMARY

This budget amendment for \$16,000 will allow the payment of consultant services for the High Technology Industry Site Study that was completed in August 1981. The revenue for this budget amendment has been received from the Economic Development Administration and deposited in the General Fund.

BACKGROUND

On May 27, 1980 the Council approved the execution of an agreement between the County and City of Sacramento for a \$16,000 (302)(a) planning grant from the U.S. Department of Commerce, Economic Development Administration. The pass-through funds were to be used for a market feasibility and land compatibility study relating to high technology industries.

A consultant services agreement was executed on December 24, 1980 with Brown and Caldwell, Consulting Engineers. The consultant completed the High Technology Industry Site Study in August 1981.

FINANCIAL DATA

On October 8, 1981 the City received \$16,000 reimbursement for consultant services from the pass-through funds from the Economic Development Administration planning grant. The funds have been deposited in the General Fund. This budget amendment to the City Manager's budget for \$16,000 will be offset by the revenue received.

RECOMMENDATION

It is recommended that the City Council adopt the attached resolution amending the City budget for FY 1981-82 for the City Manager by \$16,000 for an Economic Development Administration planning grant.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1981-82  
FOR THE CITY MANAGER'S BUDGET FOR AN ECONOMIC  
DEVELOPMENT ADMINISTRATION GRANT OF \$16,000.00

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. This budget amendment for \$16,000 will allow the payment of consultant services for the High Technology Industry Site Study that was completed in August 1981. The City Council previously approved the agreement between the County and City of Sacramento for a \$16,000 (302)(a) planning grant from the U.S. Department of Commerce, Economic Development Administration for this study. (City Agreement No. 79-241).
2. The City budget for FY 1981-82 is hereby amended:
  - a. By appropriating \$16,000 from the Unappropriated General Fund balance to the City Manager's budget 1-01-0230-0000-4258 for the purpose stated in paragraph 1 above.
3. The above appropriation increase is to be supported by additional revenues of \$16,000 that has been received from the Economic Development Administration and deposited in the Unappropriated General Fund balance.
