RECOMMENDED DECISION OF ADMINISTRATIVE LAW JUDGE REGARDING APPEAL OF AARON JENNINGS FOR INDUSTRIAL DISABILITY BENEFITS  
REJECT DECISION/APPEAL GRANTED

Phillip Bruce, Attorney at Law, represented Aaron Jennings, who was present. Richard Antoine, Deputy City Attorney, represented the Retirement System Manager.

The Commission received copies of the exhibits submitted and the transcript of the hearing held before the administrative law judge.

With the approval of Mr. Antoine, Mr. Bruce submitted written final arguments to the Commission.

Mr. Bruce and Mr. Antoine presented final arguments and rebuttals and answered questions of the Commission.

With approval of the appellant, Mr. Mayberry moved the Commission adjourn to executive session. The motion was seconded by Mr. Hermocillo.

The Chairwoman directed Mr. Bruce to prepare the decision, findings of fact, determination of issues for the Commission's review and adoption, with guidance that Mr. Jennings' injury was significant in causing the disability. Mr. Bruce was also instructed to correct the grammatical errors in the proposed decision.
