SUMMARY

Attached is a resolution by which you authorize the Executive Director to extend the present contract for meals with SmorgaBob's to July 31, 1980, the cost of which will be according to the attached price schedule.

BACKGROUND

The SENP presently serves up to 1,250 meals daily, Monday through Friday, to senior citizens in seventeen (17) locations throughout the City and County of Sacramento. The number of meals varies according to number of sites serving, weather conditions, availability of transportation, etc.

SENP currently purchases its meals for \$1.165 per meal from SmorgaBob's, Inc., under a contract which terminates on June 30, 1980.

Due to delays experienced in facility renovation, equipment installation, and personnel selection, the Central Kitchen will not be in full production by July 1. Also, SENP will not have sufficient funds to cover the start-up costs before the new fiscal year (July, 1980) budget allocations.

FINANCIAL DATA

The source of funds for meals provided by SENP are Title III-C of the Older Americans Act, Sacramento County General Funds, USDA cash, and participant donations. No City funds are involved. No increase in staff will be necessary as a result of this Resolution.

VOTE AND RECOMMENDATION OF COMMISSION



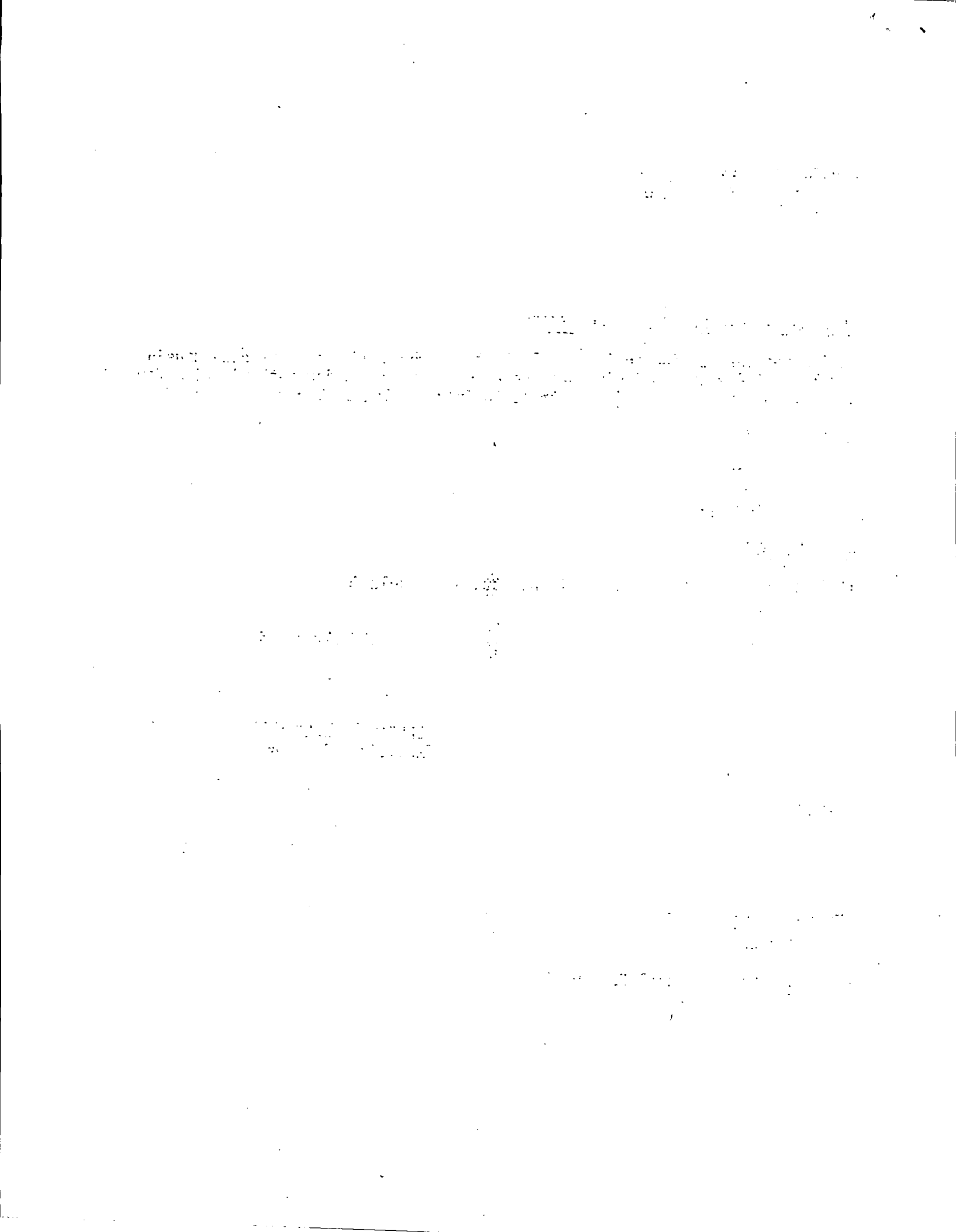


AUTHORIZING THE SACRAMENTO ELDERLY NUTRITION PROGRAM
