

ORDINANCE NO. 1118 , FOURTH SERIES.

AN ORDINANCE CLOSING, VACATING AND ABANDONING
A CERTAIN 21 FOOT STREET LOCATED IN THE CITY
OF SACRAMENTO.

BE IT ENACTED BY THE COUNCIL OF THE CITY
OF SACRAMENTO:

SECTION 1: That certain street in the City
of Sacramento, County of Sacramento, State of California,
described as follows:

All that portion of that certain 46 acre
tract of land described in deed executed by Jacob
Olsen to Felice Lagomarsino, dated August 17,
1899, and recorded August 17, 1899 in the office
of the Recorder of Sacramento County in Book 173
of Deeds at page 605, described as follows:

Beginning at a point on the southwesterly line
of a lane, and on the northeasterly boundary of that
certain 12.434 acre tract of land described in deed
executed by Geo. A. Briggs, ux., to Sutter Hospital,
dated February 27, 1944, and recorded in the office
of the Recorder of Sacramento County in Book 1106 of
Official Records at Page 81, being also a point on
the southwesterly boundary line of said 36 acre tract,
from which a concrete monument marking the inter-
section of the centerline of "C" Street with the
easterly boundary of Coloma Terrace, a plat of which
is recorded in the office of the Recorder of Sacramento
County in Book 22 of Maps, Map No. 18, bears North 34°
55' 15" West 63.85 feet; thence from said point of be-
ginning South 34° 55' 15" East 1226.26 feet along the
southeasterly line of said lane and the northeasterly
boundary line of said 12.434 acre tract, to a point
on the northerly line of "F" Street; thence North 84°
24' East 17.78 feet along the northerly line of "F"
Street on a line parallel with and 21.00 feet and distant
northerly measured at right angles from the center-
line of said "F" Street as established by the City
Engineer of the City of Sacramento; thence North 34° 55'
15" West 1224.24 feet along the northeasterly line of said
lane and the southwesterly boundary line of that certain
18.567 acre tract of land described in deed executed by
Frank B. Reardan to Aileen Reardan, dated June 29, 1926,
and recorded July 2, 1926, in the office of the Recorder
of Sacramento County in Book 76 of Official Records at
Page 452, to the northwesterly corner of said 18.567 acre
tract; thence South 89° 45' 40" West 18.85 feet along the
prolongation of the north line of said 18.567 acre tract
to the point of beginning and containing 0.436 acres
more or less,

Said closing and vacating is declared after due proceedings had therefor, according to law and a finding by the City Council, which is hereby made, that said street herein described is unnecessary for present or prospective public street purposes.
