SUBJECT: Resurfacing Sacramento City College Tennis Courts

SUMMARY

This report recommends that the City of Sacramento provide \$10,000 in Quimby fees to match \$10,000 provided by Sacramento City College to resurface the City College tennis courts which are used jointly by the City and City College.

BACKGROUND INFORMATION

Sacramento City College tennis courts are located on Sutterville Road east of Freeport Boulevard. The courts are open to the college population and general community. The City Recreation Division plans five to six tennis tournaments a year at City College with approximately 1,500 to 1,800 people participating. The City has also used the City College courts for adult and junior tennis leagues.

Resurfacing of Sacramento City College tennis courts was not included in the FY 1988-89 Capital Improvement Project budget. Since the adoption of the FY 1988-89 CIP budget, Quimby funds have become available for this geographic area, and may be used for this project.

FINANCIAL DATA

This report proposes to: (1) transfer \$10,000 from the FY 1988-89 Quimby Act Reserve funds to the Capital Improvement Program budget for the resurfacing of Sacramento City College tennis courts; and (2) amend the FY 1988-89 CIP project for resurfacing of tennis courts by expanding the scope of the project to include the Sacramento City College tennis courts.

RECOMMENDATION


It is recommended that the Budget and Finance Committee approve this report and refer it to the full City Council for action. Further, it is recommended that the City Council, by resolution, authorize the transfer of \$10,000 from the FY 1988-89 Quimby Act Reserve Account to the Capital Improvement Program budget for the resurfacing of Sacramento City College tennis courts and amend the CIP accordingly to include this project.

RESOLUTION AMENDING THE FY 1988-89 CIP BUDGET  
FOR RESURFACING SACRAMENTO CITY COLLEGE TENNIS COURTS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO that the FY 1988-89 CIP budget is hereby amended by:

1. transferring \$10,000 from the Quimby Act Reserve Fund (710-710-4012-4999) to the CIP budget for the resurfacing of Sacramento City College tennis courts (710-500-LC01-4820); and
2. changing the scope of the project to resurface tennis courts to include resurfacing of Sacramento City College tennis courts.
