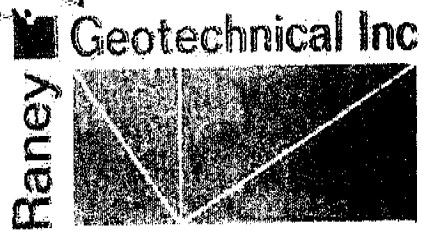

In accordance with your request, our firm has completed construction observation and testing services for the subject project. During construction of the project, our firm performed *Special Inspection and Testing* in accordance with Sections 106 and 1701 of the Uniform Building Code. Our construction observations and testing were performed between December 22, 2005 and October 23, 2006. Our firm prepared a Geotechnical Investigation Report for the project dated December 30, 2004.¹ Our observation and test results indicate that the following items for the referenced building were constructed, to the best of our knowledge, in accordance with the project plans, specifications, and our referenced report.

Earthwork: Observed and tested:
1) Building pads
2) Foundation excavations
3) Pavement subgrade and aggregate base

Reinforcing Steel: Verified placement of reinforcing steel for:
1) Foundations
2) Floor Slabs

Concrete: Observed placement and sampled concrete for:
1) Foundations
2) Slabs-on-grade

Performed slump tests and laboratory compressive strength testing

Non-Shrink Grouting: Observed Column Base Plate Grouting



