

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING

November 12, 1935

The Civil Service Board met in special session in the office of the Board at 8:00 P.M., President Deise presiding.

PRESENT: Commissioners Chenu, Stacy, President Deise:
ABSENT : None:

The minutes of meetings held September 13th; September 21st; October 2nd; October 5th and 6th; October 10th; October 15th, 16th, 17th, 22nd, and October 25, 1935; were read and there being no alterations or corrections, were ordered approved as read.

TEMPORARY EMPLOYEES

After again discussing the status of temporary employees and their periods of employment, Commissioner Stacy moved that his motion of October 10, 1935, requiring that a two year period of employment be used as a basis for consideration be rescinded. Seconded by Commissioner Chenu and carried with the following vote:

NOES: None.

The Secretary presented and read a letter from City Manager James S. Dean, dated October 31, 1935, relating to his review and study of employees now listed on the payrolls as being "temporary appointments." Mr. Dean attached a letter from City Attorney Hugh B. Bradford, stating that the following positions were exempt from Civil Service under Charter provisions:

The City Manager's letter further discussed employees who have been employed under a temporary status and also those who had been transferred from a position in which they previously had held Civil Service classifications.

CLASSIFICATIONS - EXEMPT

After discussing the above mentioned letters from City Manager Dean and City Attorney Bradford, Commissioner

Stacy moved that the positions mentioned, namely: Art Gallery Museum Attendant, Art Gallery Attendant, Superintendent of Airport, Nurse, Public Health Nurse, Dental Hygienist, Laboratory Technician, Librarians, and Golf Professionals be declared as exempt from Civil Service classification in conformity with Charter provisions. Seconded by Commissioner Chenu and unanimously carried.

AIRPORT ATTENDANT

After reviewing the recommendations of the City Manager and discussing the duties of Mechanics and personnel

at the Airport, Commissioner Chenu moved that the classification of Airport Attendant be established with a salary range of \$100.00

to \$175.00 per month, said classification to include the following qualifications:

Completion of twelfth grade of school or equivalent; general aviation background; licensed aircraft mechanic preferred; knowledge of Bureau of Air Commerce regulations and local field and traffic rules; knowledge of aircraft and aircraft engines, and how to store, service and start them under all conditions; some knowledge of tele-type, weather maps, air navigation maps and meteorology; knowledge of procedure in event of accident; general knowledge of First Aid procedure; ability to act quickly in event of emergency; ability to assume responsibility and make decisions in the absence of superior; courteous in dealing with the public; good health; agility; initiative; freedom from disabling defects.

Seconded by Commissioner Stacy and unanimously carried.

Seconded by Commissioner Stacy and unanimously carried.
