SUBJECT: Metropolitan Arts Division - Appropriation Increase for California Arts Council Grant

SUMMARY

This report recommends a \$9,500 increase to the FY 1981-82 budget of the Metropolitan Arts Division relating to the award of a California Arts Council Grant.

BACKGROUND INFORMATION

On June 12, 1981 the Sacramento Metropolitan Arts Commission received a contract from the State of California (California Arts Council) in the amount of \$9,500 to coordinate and schedule a series of regional and local technical assistance seminars.

These seminars will provide assistance to participants under the State/Local Partnership Program for the purpose of updating and correcting deficiencies in the county/city arts plans.

FINANCIAL DATA

There is no additional cost to the City. Grant expenditures will be reimbursed from revenues associated with the California Arts Council grant.

RECOMMENDATION

It is recommended that the City Council, by resolution, increase appropriations to the Metropolitan Arts Division by \$9,500 for the purpose of implementing the California Arts Council grant.

RESOLUTION AMENDING THE CITY BUDGET FOR
FY 1981-82 FOR THE DEPARTMENT OF COMMUNITY
SERVICES METROPOLITAN ARTS DIVISION
(CALIFORNIA ARTS COUNCIL GRANT)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a grant from the California Arts Council for the purpose of coordinating and scheduling a series of seminars requires an appropriation increase of \$9,500 for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
 - a. By adding thereto the sum of \$9,500 to budget number 1-01-2281-8300 relating to the expenditure of funds for the California Arts Council grant.
3. The above appropriation increase is supported by additional revenues that are forthcoming from the California Arts Council.
