SUBJECT: Resolution Authorizing Execution of Agreement Between Terra Engineering and the City of Sacramento for the Preparation of Improvement Plans for Robla Sewer Assessment District No. 1 and No. 2.

SUMMARY

Presented herewith for approval is a consultant services agreement for an amount not to exceed \$65,470 between Terra Engineering and the City of Sacramento for the preparation of engineering plans for Robla Sewer Assessment District No. 1 and No. 2.

BACKGROUND INFORMATION

This agreement is presented to conform to the guidelines of the policy for Retention of Professional Consultants for City Projects adopted February 26, 1980. The charges shall represent hourly charges for personnel involved in the work, materials, supplies, stakes, mileage and prints needed in the work process, with the total fee not to exceed \$65,470.

FINANCIAL DATA

The 1980/81 Budget includes \$100,000 from Sewer funds for plan preparation for the subject projects.

RECOMMENDATION

It is recommended that the City Manager and City Clerk be authorized to execute the subject agreement by passage of the attached resolution.
