- IV. COMMITTEE REPORTS (10 MINUTES)

ARTS DEVELOPMENT COMMITTEE (WOODLOCK) - Committee is working finalizing mission statement. They are also focusing on 3 main areas of development: 1) infrastructure and leadership, 2) increase communication, and 3) soliciting new funding sources. A marketing consultant will be present to discuss new marketing issues at the June 22nd meeting which will be held at CAC. Two new members of the committee need to go through the nomination process. Kamilos asked committee members to encourage people to join the Arts Development Committee.

L. Heller gave an update on Cultural Arts Awards Guidelines. Grants will be offered every other year instead of the yearly award given in the past; therefore, no applicants will be awarded for the second year. Scores for the applications, which the grant amount is based on, will remain the same and be kept for a two year period as long as the applicant's program does not change or have an adverse impact on grant funding (refer to page 9 of application guidelines). An interim report will be submitted by the applicant to monitor program progress. L. Heller pointed out a change to page 3, item 2A of the application guidelines, which stipulates eligibility for grant recipients whose primary office is in a contiguous county but must have 90% of their programming in Sacramento County and a 5 year programming history. Also, page 4 indicates an organization cannot receive Cultural Award grant if receiving other grant money.

L. Heller stated that although SARTA and the Poetry Center did not receive grant funding in 1998 for their organizations, they received the services of consultants. A \$1200 funding was approved for the Poetry Center for consultant services.
