SUBJECT: Sacramento Sports Commission - Appointment of One New Member

SUMMARY

This report recommends that City Council, by resolution, approve one new member to fill the unexpired term of the representative from the Sacramento Convention and Visitors Bureau on the Sacramento Sports Commission.

BACKGROUND INFORMATION

The County Board of Supervisors and City Council adopted a companion ordinance establishing the Sacramento Sports Commission on June 8 and June 14, 1988, respectively.

In accordance with those ordinances (City Ordinance No. 88-039, Section 60.152 (a) (1) through (6); and County Ordinance No. SCC 0732, Section 2.125.030, (a) (1) through (6), five members of the Sacramento Sports Commission are recommended by their respective agencies and appointed by the Sacramento City Council and the Sacramento County Board of Supervisors.

A resignation has been received by the Sacramento Sports Commission in regards to the representative of the Sacramento Convention and Visitors Bureau. The Bureau has recommended a replacement to the Sacramento Sports Commission and City Council and Board of Supervisors approval is requested.

The recommendation to the City Council and Board of Supervisors for their approval is as follows:

Sacramento Convention and Visitors Bureau: Butch Corum

With the Board of Supervisors and City Council approval of the appointment, the Commission plans to seat the new member to the Sacramento Sports Commission at their August 3, 1989 meeting.


