

RESOLUTION No. 129

Adopted by The Sacramento City Council on date of

December 4, 1942

AUTHORIZING PETITION TO COUNTY FOR ABANDONMENT OF ROAD
AND AUTHORIZING OFFER OF CITY FOR SUBSTITUTE ROAD.


RESOLVED, by the City Council of the City of Sacramento, that the City Manager be, and he is, hereby directed to petition the Board of Supervisors of the County of Sacramento to abandon the road which lies along the north boundary of the "Moulton Tract," in the said County of Sacramento, and runs westerly from 24th Street to the property of Louis and Marie Zraggen;

BE IT FURTHER RESOLVED that the City Manager be, and he is, hereby authorized to offer to the said County Board of Supervisors as a substitute a road fifty (50) feet in width, lying along the southerly boundary of the properties to be purchased by the City for the Municipal Airport expansion, which said road is described as follows:

Beginning at a point in the center of 24th Street Road (so-called), in the County of Sacramento; which said point is further described as being located South $0^{\circ} 56' 30''$ East, 444.03 feet from the northeast corner of Section 36, T. 8 N., R. 4 E., M. D. B. & M.; and which point is further described as being located North $0^{\circ} 56' 30''$ West, 49.12 feet from the southeast corner of Lot 24 of "Moulton Tract" (as the same is shown on the official map thereof filed in the office of the County Recorder of the County of Sacramento, State of California); thence from the point of beginning North $89^{\circ} 54' 28''$ West, 378.42 feet along a line parallel to and distant 49.12 feet northerly at right angles from the southerly line of said Lot 24, to a point; thence North $62^{\circ} 07' 28''$ West, 926.24 feet, to a point; thence North $89^{\circ} 54' 30''$ West, 129.42 feet, to a point on the westerly line of Lot 1 of said "Moulton Tract;" thence North $0^{\circ} 24' 30''$ East, 12.21 feet, to the northwest corner of said Lot 1; which point is the southwest corner of Tract 8 of "L. R. Davis Estate" (as the same is shown on the map thereof filed in the office of the County Recorder of the County of Sacramento, State of California, in Book 3 of Surveys, Map No. 77); thence North $0^{\circ} 23' 16''$ East, 43.89 feet along the westerly line of said Tract 8, to a point; thence South $89^{\circ} 56' 42''$ East, 129.55 feet; thence South $62^{\circ} 07' 28''$ East, 940.06 feet, to a point; thence South $89^{\circ} 54' 28''$ East, 364.84 feet along a line parallel to, and distant 99.12 feet northerly at right angles from, the southerly line of said Lot 24 of "Moulton Tract," to a point on the easterly line of said Lot 24; thence South $0^{\circ} 56' 30''$ East, 50.00 feet, to the point of beginning; and containing 1.668 acre, more or less.
