SUBJECT: Rejection of Bids and Readvertisement for Bids for the
Purchase of Compact Pick Up Trucks

BACKGROUND INFORMATION

The Equipment Maintenance Division has a requirement for the purchase of 9 each short wheelbase, 16 each long wheelbase and 3 each long wheelbase with extra large cab compact pick up trucks and 11 each long wheelbase cab and chassis. Formal bids (Bid No. 433) were solicited and received February 16, 1982. However, since changes in the quantity and specifications for these vehicles are necessary, it has been determined to be in the best interest of the City to reject all bids and readvertise for bids for this requirement.

RECOMMENDATION

Pursuant to Section 57.305 of the Sacramento City Code, it is recommended that the City Council reject all bids and, pursuant to Section 57.307, re-advertise for bids with amended specifications for the purchase of 9 each short wheelbase, 14 each long wheelbase and 5 each long wheelbase with extra large cab compact pick up trucks and 11 each long wheelbase cab and chassis. It is recommended that these bids be due Tuesday, April 6, 1982.
