SUBJECT: Metropolitan Arts Division - Appropriation Increase for
California Arts Council Grant

SUMMARY

This report recommends an increase in appropriations of \$18,750 to the FY 1981-82 budget of the Metropolitan Arts Division relating to the award of a California Arts Council grant.

BACKGROUND INFORMATION

On August 25, 1981, the City Council adopted Resolution Number 81-625 authorizing the City Manager, on behalf of the Sacramento Metropolitan Arts Commission, to submit a grant application to the California Arts Council for the Technical Assistance Program.

On December 30, 1981, the Sacramento Metropolitan Arts Commission received notification of an \$18,750 grant award to implement the Technical Assistance Program beginning January 1, 1982, through September 30, 1982. \$13,685 will be expended in FY 1981-82 and \$5,065 in FY 1982-83.

FINANCIAL DATA

There are no indirect costs associated with this grant. Expenditures will be reimbursed from revenues associated with this grant. A 50/50 match is required and will be provided through corporate support and in-kind contributions. No additional City or County funds are necessary.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1981-82
FOR THE DEPARTMENT OF COMMUNITY SERVICES (METRO
ARTS DIVISION - CALIFORNIA ARTS COUNCIL GRANT)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a grant from the California Arts Council to conduct the 1982 Technical Assistance Program requires an appropriation for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
 - a. By adding thereto the sum of \$18,750 to budget number 1-01-2281-7244 relating to the expenditure of funds for the California Arts Council's grant.
