

RESOLUTION NO. 2006-515

Adopted by the Sacramento City Council

July 18, 2006

APPROVING PLANS AND SPECIFICATIONS, ACCEPTING LOW BID, APPROPRIATING FUNDS AND AWARDING CONTRACT FOR FOLSOM BOULEVARD LEFT TURN POCKET AT 64TH STREET PROJECT (PN: TF91)

BACKGROUND

- A. The Folsom Boulevard Left Turn Pocket at 64th Street Project (PN: TF91) will construct a left turn pocket westbound into the Office Depot Shopping Center. The improvements include street widening and resurfacing, curb, gutter, and sidewalk construction, storm drainage, utility modifications and signing and striping.
- B. This project was advertised and bids were received on March 17, 2006. The bids are summarized below:

Contractor	Bid Amount	ESBE Participation Goal 20%
Martin Brothers Construction	\$208,630	18.7%
Biondi Paving	\$212,167	24.8%

The engineer's estimate was \$130,000.

The low bidder Martin Brothers Construction did not meet the ESBE participation goal. The low bidder must meet this goal for the bid to be deemed responsive. It is recommended that the contract be awarded to Biondi Paving for its lowest responsive and responsible bid.

- C. Construction is expected to begin in August 2006 and be completed in September 2006.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Plans and specifications for the Folsom Boulevard Left Turn Pocket At 64th Street Project (PN: TF91) are approved.
- Section 2. The low responsive and responsible bid of Biondi Paving in the amount of \$212,167 is accepted.

- Section 3. The FY06/07 Capital Improvement Program budget is amended by appropriating \$86,006 (Fund 201) to the Folsom Boulevard Turn Pocket at 64th Street Project (PN:TF91).
- Section 4. Staff is directed to bring a Measure A (Fund 201) reallocation request in the amount of \$86,006 to the Sacramento Transportation Authority (STA) Board for approval.
- Section 5. The City Manager is authorized and directed to execute a contract in the amount of \$212,167 with Biondi Paving for the Folsom Boulevard Left Turn Pocket At 64th Street Project (PN: TF91).



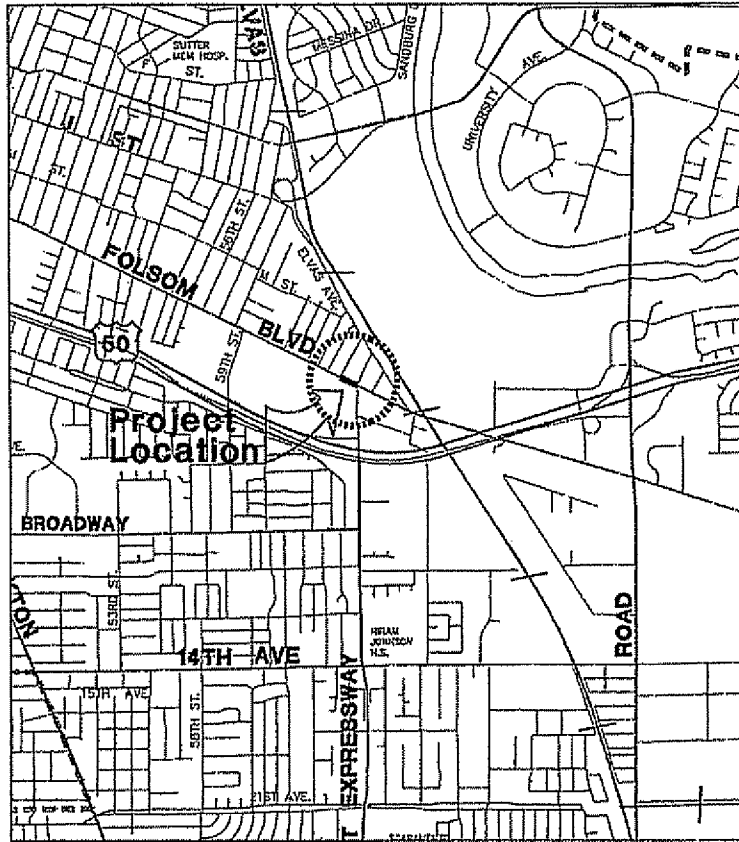
