Dear Henry,

In response to your question regarding the tile wall assembly, CTA Assembly #W244 is recommended in wet areas, such as showers and cart wash rooms. I feel that this dishroom does not get as much water exposure as these "wet" areas, and is well-ventilated. Therefore I feel it is acceptable to use standard self-tapping drywall screws at the existing walls where non-corrosive screws of adequate length to fasten cement board through two layers of 5/8" gypsum board are not available.


