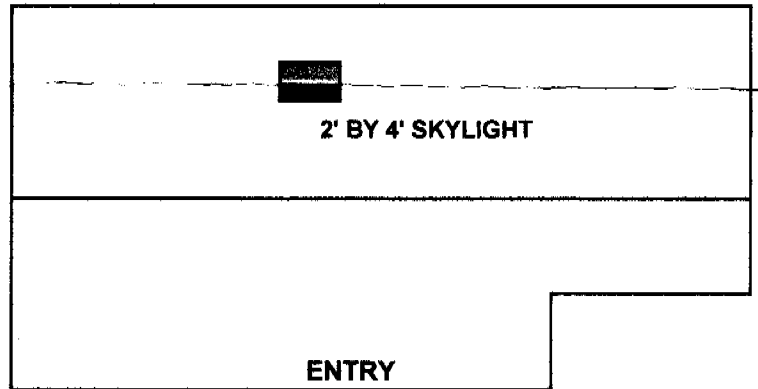
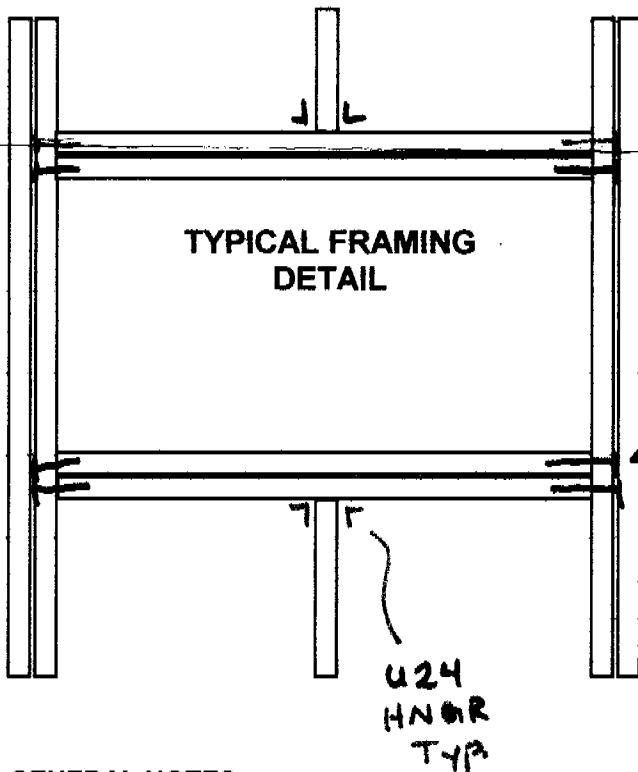
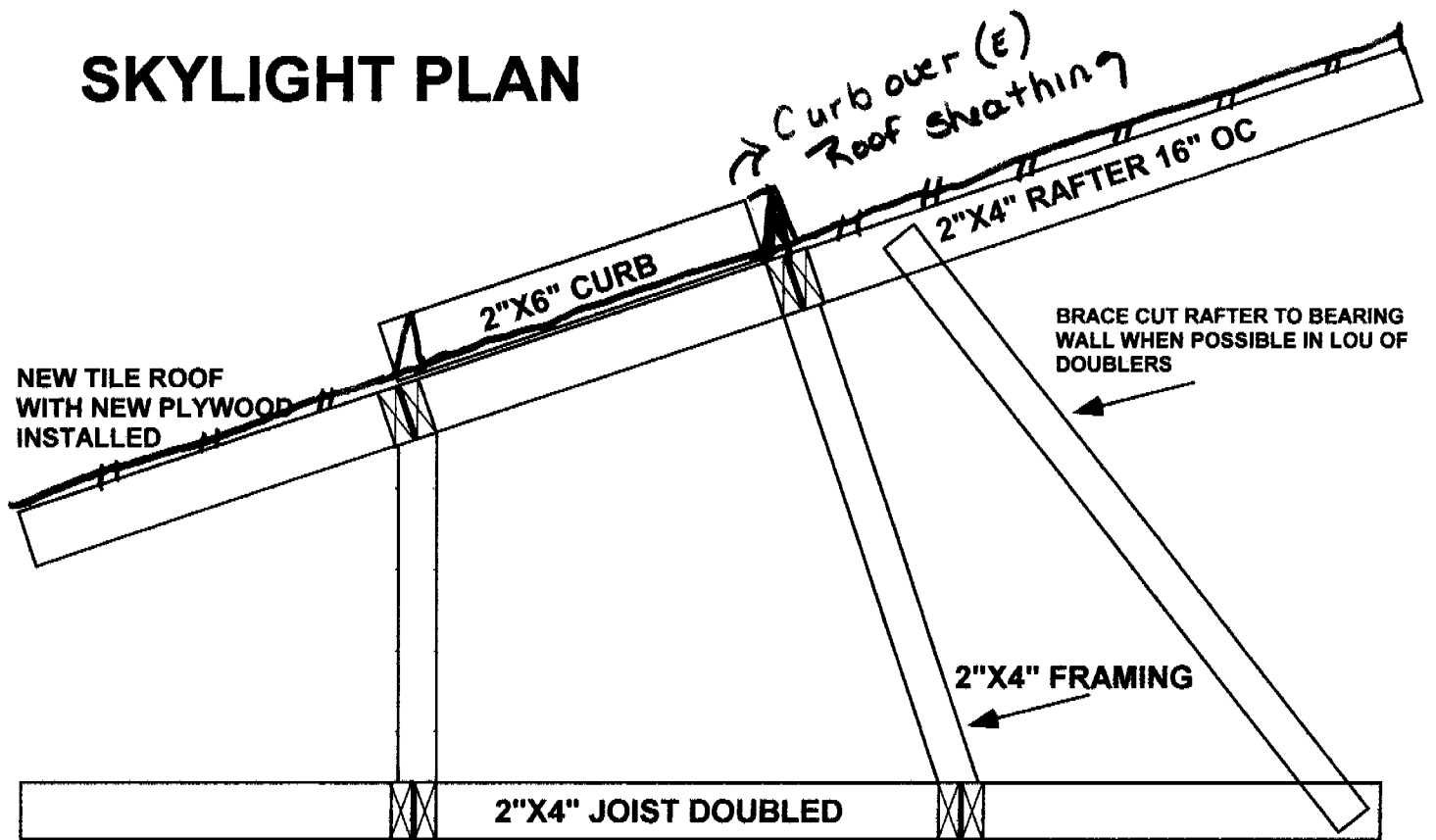

2. Double rafters and headers only if cut rafter cannot be supported to bearing point with struts as shown.
3. When doublers are required install to bearing points such as bearing wall, purlin brace or ridge board.
4. All connections use min. 3 each 16n nail.
