#### **Description/Analysis**

**Issue:** The Department of Transportation entered into a contract with Jackson Electric for the Maintenance of Street Lighting (Re-Lamping) on June 20, 2006. The current supplemental agreement expires June 30, 2008, with one (1) final option period remaining. The City has a continuing need for relamping services Citywide. Jackson Electric has consistently performed in accordance with the terms and conditions of the contract.

**Policy Considerations:** The recommendations in this report are consistent with Sacramento City Code Section, 3.56, Purchasing of Supplies and Services, as well as API 1, Procurement of Supplies and Nonprofessional Services.

**Environmental Considerations:**

**California Environmental Quality Act (CEQA):** Under the California Environmental Quality Act (CEQA) guidelines, continuing administrative activities do not constitute a project and are therefore exempt from review.

**Sustainability Considerations:** The re-lamping of the street light services purchased under this contract meets the City of Sacramento's Sustainability Master Plan by improving and optimizing the transportation infrastructure.


**Commission/Committee Action:** None


**Financial Considerations:** The Streets Services Division, Signals and Lighting Section, has sufficient funding available in their CIP and operating budgets for this service.
