Mr. Beaton requested information from the Board relative to his discharge from the Recreation De-

partment February 5, 1936. A letter from Mr. Maloney, Superintendent of Recreation, dated May 18, 1936 was read wherein he stated in part "Because of continued absence from his work and because of his attitude while working, it became necessary to give him a sixty-day lay-off during the summer of 1935" and ".....it finally became necessary to discharge him." After discussion, the Board informed Mr. Beaton that there was nothing they could do


