The Civil Service Board met in special session in its office at 5 o'clock P.M.


PRESENT: Commissioners Cavanaugh, Deise and Root

Request to have name
restored to Laborer

Mr. Gomes requested, through the Civil Service Office, that his name be restored to Laborer Eligible Register

#145 as he had enlisted in the Merchant Marine May 5, 1942. His name had been removed by the Civil Service Board April 12, 1945 for failure to report upon certification. The Secretary was instructed to have Mr. Gomes produce evidence indicating he was in the Merchant Marine Service at the time of his certification and upon proper evidence produced, his name will be restored to the Laborer Eligible Register #145.

PREVAILING RATE SCALE
FOR CARPENTERS

A communication from J. B. Russell, Secretary-Treasurer of the Sacramento-Yolo Counties District, Council of

Carpenters received by the Board September 18, 1945 was read. It advised the Board

that the Wage Adjustment Board in Washington, D.C. had awarded to the local Council of Carpenters an increase of wages of ~~12¹/₂~~ per hour or \$1.00 per 8-hour day. A letter from Walter Henderson, Foreman City Carpenter Shop, dated September 28, 1945, informing the City Civil Service Board of the increase in Carpenter's pay scale was read. After review and investigation, it was the findings of the Board that the prevailing wage for Carpenters in this area is \$1.50 per hour or \$12 per day. The Secretary was instructed to advise the City Council of the Board's findings.
