Specifically, such a program or programs will provide a five-percent (5%) bid evaluation preference to small businesses located within the City of Sacramento; and a two-and one-half percent (2.5%) bid evaluation preference for small businesses located within the County of Sacramento with direction to staff to a) do analysis of the 3 year history (or 2009 if 3 years is too extensive) of local business bids for the City of Sacramento related to construction and professional services and b) direction to report back to Council one year after the Ordinance is implemented; and 2) forwarding the approved ordinance to the full City Council for adoption.
