Steve Peterson, Senior Planner, reviewed this item. The Hedge Avenue project has problems with hazardous materials and is on hold until the Health Department gives an okay. There is a problem with share payments from the property owners through LAFCO, but that is being solved. LAFCO needs to reevaluate Shorebird. In Sand Cove, payments and EIR issues need to be resolved.

Council member Fargo asked if the City retains right of way to the river before annexation. Staff responded that when the City grants approval of annexation it retains river access.


Steve Peterson, Senior Planner, reviewed this item. Staff concurs with Mr. Sorenson's request to detach from the city.


