STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Provide new 5" ogee gutters throughout.
2. ~~Replace decorative rafter tails as necessary.~~ Replace with 2 x 3 rafter tails in identical locations as originals.
3. Repair/replace existing drip edge as necessary. Match existing.
4. Cutting of rafter tails on rear elevation is permitted. Cut to align with edge of roof.
5. Paint all new exterior woodwork to match existing.
6. The scope of work is limited to the above listed items. Any changes are subject to Design Review staff approval.
