Description/Analysis

Issue: The City of Sacramento's Department of Parks and Recreation Teen Services section is partnering with People Reaching Out, Inc. (People Reaching Out) to provide recreation, life skills and drug prevention programming to teens in the Valley Hi Community located in south Sacramento. People Reaching Out received a grant to promote this effort and is interested in utilizing the City of Sacramento's Department of Parks and Recreation Teen Services staff to operate the recreational aspect of the program. Council approval is required since the City is operating in a service provider capacity.

Policy Considerations: Staff's recommendation is consistent with policies in the City Council adopted *2005-2010 Parks and Recreation Master Plan* including:

Policy 6.9: Partner with School Districts and other local and regional agencies to maximize funding opportunities.

Policy 12.1: Actively pursue and formalize partnership agreements with a broad range of public and private entities.

Policy 12.7: In partnership with other agencies, promote provision of a complete continuum of care in social services for all residents, participating in varied roles in their delivery.

Additionally, providing Parks and Recreation services is consistent with the City's strategic plan to achieve sustainability and livability and to expand economic development throughout the City.

Environmental Considerations:

California Environmental Quality Act (CEQA):

This report concerns administrative activities that will not have any significant effect on the environment and that do not constitute a "project", as defined by the following sections of the CEQA Guidelines (Title 14 Cal. Code Reg. § 15000 et seq.): Sections 15061 (b)(3); 15378(b)(2).

Sustainability Considerations: The agreement between People Reaching Out and the City of Sacramento has been reviewed for consistency with the goals, policies and target of the Sustainability Master Plan and the 2030 General Plan.


Commission/Committee Action: None with this item.

Rationale for Recommendation: The City of Sacramento is committed to providing services to youth and teens that promote recreation, life skills and drug prevention programming. Through partnership with People Reaching Out, the City is able to participate in the offering of a full spectrum of comprehensive services for teens that includes recreation, life skills training and drug prevention programming that might not otherwise be available to this community. Council approval is required since the City is operating in a service provider capacity.

Financial Considerations: There is no impact to the General Fund associated with this item. All expenses will be reimbursed to the General Fund upon program completion within Fiscal Year 2011 in an amount not to exceed \$5,890.

Background

The Department of Parks and Recreation provides after school recreation and enrichment programs for children ages 6 – 12 years in the Valley Hi Community through the Sacramento START program. Additionally, the Department provides an after school program at Valley High School for youth in grades 9 – 12. Currently, the Department does not provide any programming in the Valley Hi Community for middle school youth.

Through a partnership with People Reaching Out, Inc. (People Reaching Out) the Department of Parks and Recreation has an opportunity to provide the Valley Hi Community with evening recreation and enrichment programming for youth ages 12 – 18 years old. This program will include recreation, life skills training and drug prevention components.

People Reaching Out was awarded a Multi-Family Housing Grant from the City's Office of Youth Development. As part of the grant proposal, People Reaching Out desires to contract with the Department of Parks and Recreation to deliver an evening recreation program for youth in the Valley Hi Community. The program will operate Monday, Wednesday, and Friday from 6:00pm – 9:00pm, September 6 – December 31, 2010.

All direct costs incurred by the City through the operation of the program will be reimbursed by People Reaching Out. Therefore, no general fund support is required.

AGREEMENT: PEOPLE REACHING OUT

BACKGROUND

- A. The Department of Parks and Recreation provides after school recreation and enrichment programs for children ages 6 – 12 years in the Valley Hi Community through the Sacramento START program. Additionally, the Department provides an after school program at Valley High School for youth in grades 9 – 12. Currently, the Department does not provide any programming in the Valley Hi Community for middle school youth.
- B. Through a partnership with People Reaching Out, Inc. (People Reaching Out), the Department of Parks and Recreation has an opportunity to provide the Valley Hi Community with evening recreation and enrichment programming for youth ages 12 – 18 years old.
- C. People Reaching Out was awarded a Multi-Family Housing Grant from the City's Office of Youth Development. As part of the grant proposal, People Reaching Out desires to contract with the Department of Parks and Recreation to deliver an evening recreation program for youth in the Valley Hi Community. The program will operate Monday, Wednesday, and Friday from 6:00pm – 9:00pm, September 6 – December 31, 2010.
- D. All direct costs incurred by the City through the operation of the program from September 6 through December 31, 2010 will be reimbursed by People Reaching Out. Therefore, no general fund support is required.
- E. Council approval is required since the City is operating in a service provider capacity.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Manager, or a designated representative, is authorized to execute an agreement between the City and People Reaching Out, Inc. in an amount not to exceed \$5,890 for the Department of Parks and Recreation to deliver teen services to the Valley Hi Community.
- Section 2. The agreement is attached as Exhibit A and is a part of this resolution.

September 6 RECREATION SERVICES AGREEMENT

This recreation services agreement ("Agreement") is made and entered into on _____, by and between the City of Sacramento, a municipal corporation ("City"), and People Reaching Out, Inc., a California corporation ("People Reaching Out").

WHEREAS, People Reaching Out desires to contract for recreation services; and

WHEREAS, City is willing to provide recreation services on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual promises contained in this Agreement, City and People Reaching Out agree as follows:

1. Scope of Services:

The services provided shall be as set forth in Exhibit A, attached hereto and incorporated herein.

2. Term

The term of this agreement shall commence on date September 6, 2010 and end on December 31, 2010.

3. Payment:

Payment to the City shall be made within 30 days after receipt of the City's invoice in an amount not to exceed \$5,890.

4. Indemnity:

A. People Reaching Out shall defend, hold harmless and indemnify City, its officers and employees, and each and every one of them, from and against any and all actions, damages, costs, liabilities, claims, demands, losses, judgments, penalties, costs and expenses of every type and description, including, but not limited to, any fees and/or costs reasonably incurred by City's staff attorneys or outside attorneys and any fees and expenses incurred in enforcing this provision (hereafter collectively referred to as "Liabilities"), including but not limited to Liabilities arising from personal injury or death, damage to personal, real or intellectual property or the environment, contractual or other economic damages, or regulatory penalties, arising out of or in any way connected with performance of or failure to perform this Agreement by People Reaching Out, any subcontractor or agent, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, whether or not (i) such Liabilities are caused in part by a party indemnified hereunder or (ii) such

Liabilities are litigated, settled or reduced to judgment; provided that the foregoing indemnity does not apply to liability for any damage or expense for death or bodily injury to persons or damage to property to the extent arising from the sole negligence or willful misconduct of City, its agents, servants, or independent contractors who are directly responsible to City, except when such agents, servants, or independent contractors are under the direct supervision and control of People Reaching Out.

B. The provisions of this section 4 shall survive the expiration or earlier termination of this Agreement.

5. Insurance:

People Reaching Out, at its sole cost and expense and for the full term of this agreement, shall obtain and maintain a comprehensive general liability insurance policy with a minimum limit of not less than \$1,000,000 combined single limit per occurrence for bodily injury and property damage, providing at least all of the following minimum coverages:

- A. Premises Operations
- B. Blanket Contractual
- C. Personal Injury

All or a portion of the required insurance may be satisfied through the use of a self-insurance program or pooled insurance, if any. People Reaching Out must provide an affidavit of self-insurance, or pooled insurance if any, upon request of the City. The foregoing insurance requirements are not intended to and shall not in any manner limit, alter, or qualify the liabilities and obligations otherwise assumed pursuant to this Agreement, including, but not limited to, the provisions concerning indemnification.

6. Notices:

All invoices, payments or other notices to City or People Reaching Out, shall be delivered in person or sent by first class mail, postage prepaid, to the persons indicated below.

Exhibit A

A. City of Sacramento Parks and Recreation will:

- Provide one (1) Senior Recreation Aide and one (1) Recreation Aide to implement and supervise 50 youth participants.
- Provide a program liaison to facilitate the arrangement within this contract.
- Attend three meetings throughout the course of this contract to discuss progress of the program.
- Assist with program recruitment.
- Provide any necessary forms required by Grantee.
- Provide youth with enrichment activities including sports, dancing, and arts and crafts.
- Provide People Reaching Out with data needed for evaluation and program reports as per grantee requirements.

B. People Reaching Out will:

- Provide a program liaison to facilitate the arrangement within this contract.
- Recruit youth to participate in the program.
- Provide necessary support to the implementation of the program.
- Create and implement all evaluation surveys, reports and updates on program implementation.
- Be the liaison between People Reaching Out, the City of Sacramento Office of Youth Development, and the City of Sacramento Parks and Recreation.
- Facilitate three meetings throughout the course of this contract to discuss progress of the program.
