SUBJECT: Award of Contract for the construction of the Old

Sacramento Riverfront Buildings and Boardwalks

SUMMARY

This report recommends the adoption of the attached resolution which authorizes the Executive Director to award and execute a contract for the construction of the Old Sacramento Riverfront Buildings and Boardwalks to Kimmel Construction, Inc., for a total Schedule A bid of \$1,708,304 and to approve \$665,304 to be transferred from the Docks Project to Old Sacramento to augment the fund balance for this project.

BACKGROUND

Construction of the Old Sacramento Riverfront Buildings and Boardwalks which includes site improvements, landscaping, area lighting and utilities is an integral part of the Phase II improvements previously approved as a portion of the Old Sacramento Riverfront Project. Resolution No. 84-004 adopted January 24, 1984 approved a revised phasing and financing plan for the reconstruction of the Old Sacramento waterfront and authorized the Executive Director to include Phase II construction activity as an activity to be funded by tax allocation bonds. The resolution further authorized the Executive Director to take all actions necessary to complete construction of the riverfront buildings per the revised phasing and financing plan.

Construction Documents for the Riverfront Buildings and Boardwalks have been completed and the project advertised for bids. Bids were received June 5, 1985. Per the project schedule, award of the construction contract is to occur in June 1986 with construction to commence in July.

The bid tabulation sheet for this project is attached as Exhibit I. The apparent low bidder on Schedule A is Kimmel Construction, Inc.

It is staff's opinion that the cost differential between Schedule A and B is such that no savings will be experienced by delaying and rebidding those portions of the work detailed under Schedule B and C.

Therefore, the staff is recommending Schedule A to be awarded to the lowest responsible bidder which is Kimmel Construction, Inc. at \$1,708,304.

FINANCIAL DATA

84-004 adopted January 24, 1984 approved a Resolution No. revised phasing and financing plan for the reconstruction of the Old Sacramento Waterfront and authorized the Executive Director to take action consistent with the revised plans and the approved resolution. The resolution authorizes actions in accordance with and not exceeding the amounts stated in the revised financing plan. Subsequent to the adoption of that the Agency's 1986 adopted budget appropriated resolution funds Old Sacramento Riverfront Capital carryover for Improvements totaling \$915,000 for the construction of the Riverfront and Wharf Buildings and \$800,000 for Phase From the combined total of \$1,715,000 construction. subsequent commitment of funds for the construction of permanent moorage facility for the Delta King and tour boats has revised the amount available for the construction of the Riverfront Buildings and Boardwalks to approximately \$1,200,000.

In addition to the low bid of \$1,708,304, the Agency will incur construction management costs from the City of Sacramento, Facilities Management Division. This Division is currently providing construction management to the Agency on Phase I of the waterfront. Their fee, for Phase II including the Delta King/Globe moorage facilities is \$108,000.
