Weston gave a brief presentation on the New Works Award Program. She stated the 2001 New Works Award Program is intended to increase resources and opportunities for local artists by making grants available to create an original work of art and present it to the general public. The process of the grant has been revised to help the applicant in filling out the application. The grants are awarded in a competitive process which involves a formal written application reviewed by a panel of arts professionals. Applications will be available on September 29th. Workshops will be held in October. The final deadline for applications and supporting material is November 9th. Up to \$40,000 will be awarded in grants ranging from \$1,000 to \$2,500 per project. The number of awards and specific amounts will be recommended by the Awards Committee.

Porembski presented a report on the arts plan for the Public Safety Administration Building project and the request for an approval exception to APP Policy Guidelines for artist eligibility. The proposed site, which is known as "Freeport Square", is located on Freeport Boulevard. It will be the future location of Fire and Police Department Administration operations. The building will be refurbished in two phases. Porembski has met with the project team who expressed a desire to commission artwork that honors the public safety theme. The only tentative area available for public access in the project building is in the entry vestibule. The artwork could also be located along the promenade leading to this entrance. Artwork may consist of free-standing sculpture; hanging elements; two or three dimensional wall mounted artwork; inset floor finish; and vertical glazing elements, etc. There was a consensus of the project team to use the invitational selection process due to time constraints. They have requested Jesus Romo, Battalion Fire Chief, who is also a sculptor and public artist, as the artist to be granted commission for the project. In addition to being an artist, Mr. Romo has 26 years of career service to public safety. He will be retiring within the next 3 to 6 months, therefore, the project team is requesting an exception be made to this guideline for this particular project. The project budget is approximately \$102,000 of which \$81,600 will be specified for the artwork, fabrication and installation, and \$20,400 for administration cost.

Wong questioned the procedure for making an exception to consider a city employee as an artist for this project. Walker stated commission can only recommend approval. The City Manager and possibly Council may need to address the issue regarding the exemption policy. Kamilos suggested the Commission consider a conditional recommendation. Friedman stated a letter of intent be sent to the City Manager or City Attorney addressing the exemption. She also questioned if the exemption would interfere with the conflict of interest statement. Walker stated the issue may need to be forwarded to City Council for their approval in addition to the City Manager and Attorney's review. Kamilos suggested a conditional approval pending City Managers approval.

Bloom presented information regarding the arts plan for Southside Park. The project consists of a new community center added to the existing Southside Park poolhouse. The features in the facility include the lobby area, three meeting rooms, a concession/kitchen, and restrooms. Through a community funded arts education project, a mural depicting joggers will be added to the exterior wall of the poolhouse this year. The community has expressed the need for public artwork that depicts historical items and events in the neighborhood. They have also requested the neighborhood children be involved. Potential artwork locations include an installation on the 20 foot high wall in the lobby. This location will be visible from the entrance to the building and from the pool. The project is designed by Ekistics Design Studio. The construction is scheduled for completion in December 2001.
