

**Environmental Considerations:**

**California Environmental Quality Act (CEQA):** Establishment of Capital Improvement Projects and transferring of funds are not subject to the provisions of the California Environmental Quality Act (CEQA) under the general rule (Section 15061 (b)(3)) that CEQA applies only to projects that have the potential for causing a significant effect on the environment.

**Sustainability Considerations:** Maintaining the Howe Avenue bridges and the I Street, J Street, and Jibboom Street viaducts meets the City’s sustainability goals by preventing further deterioration and extending the lifetime of these bridges and viaducts.

**Other:** None.

**Commission/Committee Action:** None.

**Rationale for Recommendation:** The Howe Avenue bridges and the I Street, J Street, and Jibboom Street Viaducts require maintenance to increase the useful lives of the bridges and viaducts.

**Financial Considerations:** The estimated budget for the Howe Avenue Bridges Maintenance Project (T15115700) is \$1,005,900. The total budget of \$1,005,900 for the Howe Avenue Bridges Maintenance Project (T15115700) will be provided from the following projects:



## **Attachment 1**

### **Background:**

Caltrans inspects the City of Sacramento bridges and viaducts and provides inspection reports with recommended work. An inventory was done on all the bridges in the City, and the work required on each. Different types of maintenance were evaluated and ranked, based on how that type of maintenance could extend the life of the bridges and the potential cost of future rehabilitation if new term maintenance is not undertaken. The Howe Avenue bridges and the I Street, J Street, and Jibboom Street viaducts were identified as having multiple high ranked maintenance needs.

The six Howe Avenue bridges have worn asphaltic concrete overlay and deck cracking, and need deck maintenance. These bridges also have worn joint seals that have collected debris that do not allow the bridges to properly expand and contract. There is also erosion at the abutments.

The I Street, J Street, and Jibboom Street viaducts have deck cracking. These bridges also have worn joint seals that do not allow the bridges to properly expand and contract. There are also minor concrete spalls to correct and damaged railing that needs to be replaced.

Staff recommends creating two new Capital Improvement Projects, the Howe Avenue Bridges Maintenance Project (T15115700) and the I Street, J Street, and Jibboom Street Viaducts Maintenance Project (T15115600) to provide maintenance to these bridges. The proposed projects will complete all work as recommended by the Caltrans inspection reports.

**ESTABLISH TWO CAPITAL IMPROVEMENT PROJECTS AND TRANSFER OF FUNDS TO THE HOWE AVENUE BRIDGES MAINTENANCE PROJECT AND THE I STREET, J STREET, AND JIBBOOM STREET VIADUCTS MAINTENANCE PROJECT**

**BACKGROUND**

- A. Caltrans inspects City bridges and viaducts and provides inspection reports with recommended work.
- B. These projects are funded with Measure A – Maintenance and Traffic Congestion Relief Program funds.
- C. Staff recommends implementing the Capital Improvement Projects at this time.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The Howe Avenue Bridges Maintenance Project (T15115700) and the I Street, J Street, Jibboom Street Viaducts Maintenance Project (T15115600) are established as new Capital Improvement Projects.
- Section 2. The FY10/11 Capital Improvement Program is amended by transferring \$231,211 (Fund 2005) from Bridge Renovation Project (T15078900), \$454,547 (Fund 2005) from the Bridge Maintenance Design Structure Project (T15078100), \$79,202 (Fund 2005) from the Bridge Maintenance Program (R15072200), \$50,000 (Fund 2026) from the Bridge Construction and Maintenance Project (R15102300) and \$190,940 (Fund 2009) from Bridge Construction and Maintenance (T15112300) to the Howe Avenue Bridges Maintenance Project (T15115700)
- Section 3. The FY10/11 Capital Improvement Program is amended by transferring \$610,000 (Fund 2009) from Bridge Construction and Maintenance (T15112300) to the I Street, J Street, and Jibboom Street Viaducts Maintenance Project (T15115600).

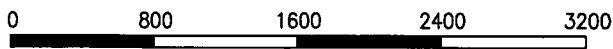
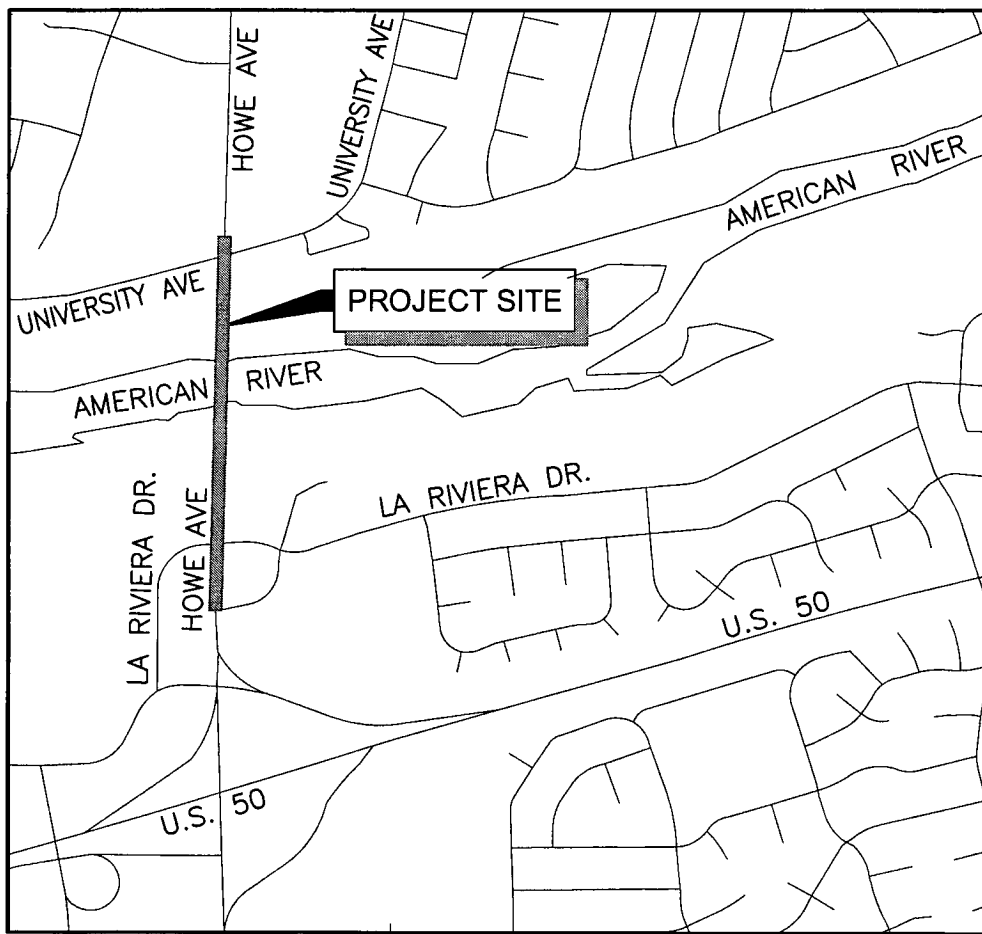

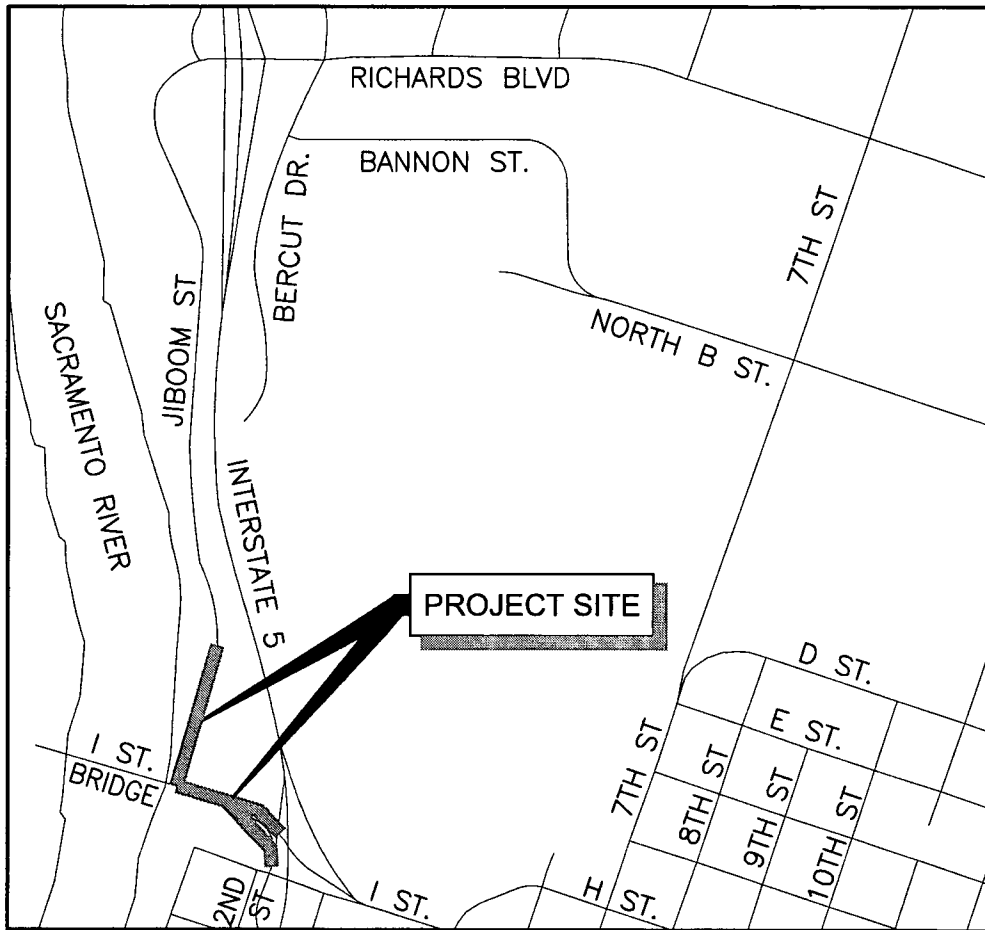
