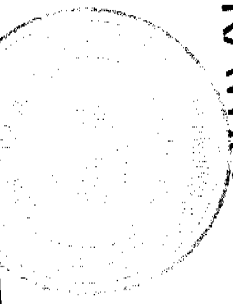
GENERIC CABINET DRAWING
