Article VII is hereby amended by adding a new section to be numbered Section 52-A and shall read as follows:

VIOLATION AND PENALTIES

SECTION 52-A: It shall be the duty of the Secretary to supervise the execution of the Civil Service provisions of this Charter and the rules made thereunder, and it shall be the duty of all persons in the service of the City to comply with such rules and to aid in their enforcement.

Any board member, examiner, or any other person who shall wilfully or corruptly, by himself or in cooperation with others, defeat, deceive or obstruct any person in respect to his or her right to examination or registration according to the regulations prescribed pursuant to the provisions of this article, or who shall, wilfully or corruptly, falsely mark, grade, estimate or report upon the examination or proper standing of any person examined, registered or certified according to any regulation prescribed pursuant to the provisions of this article, or aid in so doing or shall wilfully or corruptly make any false representations concerning the same, or concerning the persons examined, registered or certified, or who shall wilfully or corruptly furnish to any person any special or secret information for the purpose either of improving or injuring the prospects or chances of any person so examined, registered or certified, or to be examined, registered, or certified, or who shall personate any other person, or permit or aid in any manner any other person to personate him, in connection with any examination or registration or application, or request to be examined or registered, shall be deemed guilty of a misdemeanor, and upon conviction thereof, be punished by a fine of not less than fifty dollars (\$50.00) nor more than five hundred dollars (\$500.00), or by imprisonment for a term not to exceed six (6) months.

Amending Section 165 of Article XX "Officers and Employees" to read as follows:

GENERAL QUALIFICATIONS

SECTION 165: Every officer or employee of the City must be a citizen of the United States and a resident of the City of Sacramento not less than three (3) consecutive years immediately preceding his appointment. All City employees must reside within the City Limits. In case of flood, fire, or other public calamity, the City Manager may employ on City work, persons other than citizens or residents. The provisions of this section regarding three (3) years residence may not apply in the case of the City Manager and may be waived by the Civil Service Board because of difficulty in securing applicants for positions requiring peculiar and exceptional qualifications of a professional or expert character.
