SUBJECT: Request for Resolution authorizing an increase in the Library's budget by \$26,247, carryover funds under a Library Services and Construction Act (LSCA) grant

SUMMARY

In May 1980, the Library was awarded a Library Services and Construction Act (LSCA) grant in the amount of \$32,900 to be used for producing an on-line catalog database. Request was made to the State Library and approved for the carryover of \$26,247 remaining monies for fiscal year 1981/82. The Library is therefore requesting authorization for an increase in Library appropriations for FY 1981/82 in the amount of \$26,247.

BACKGROUND

The LSCA grant awarded the Library in 1980 was to be used for producing an on-line catalog database involving the purchase of equipment and the mounting of our present database with an on-line vendor. The equipment was installed in late June, 1981, and training of staff is underway for full on-line cataloging. There was insufficient time to mount the database prior to the end of FY 1980/81; subsequently, a request was made to the State Library for approval to carry over the unused portion of the grant for this purpose into FY 1981/82, which has been granted.

RECOMMENDATION

It is therefore recommended that your Council approve the attached resolution authorizing an increase in the Library budget of \$26,247.
